Certificate of Incorporation

We, the undersigned, The Chairman and Secretary of the meeting herein named do hereby certify that on the 2d day of April 1890 The persons of full age belonging to a religious Society in which divine worship is maintained according to the rites of the Baptist Church and not already incorporation, met at the place of worship heretofore occupied by said Society, in the Village of Niagara Falls, Niagara County, N.Y. for the purpose of incorporating themselves and did then and there elect by a majority of ballots William A. Jamison, George H. Kennedy, William A. Phillpott, Sr., Matthew Jackson, Walter P. Wilson, and James V. Banks as trustees of such society and the said persons did then and there determine by a like majority of ballots that said corporation should forever hereafter be called and known by the name of First Baptist Church in Niagara Falls.

We further certify that the notices required by law was duly given of such meeting, that the object time and place of such meeting was distinctly stated in such notices.

That all the persons so voting at said meeting were duly authorized by law to vote thereat, and that the persons so elected trustees were qualified voters at such meeting.

We further certify that we the undersigned were the Chairman and Secretary of the meeting aforesaid.

In Witness Whereof we have hereunto set our hands and seals as Chairman and Secretary of the meeting aforesaid this 21st day of May 1890.

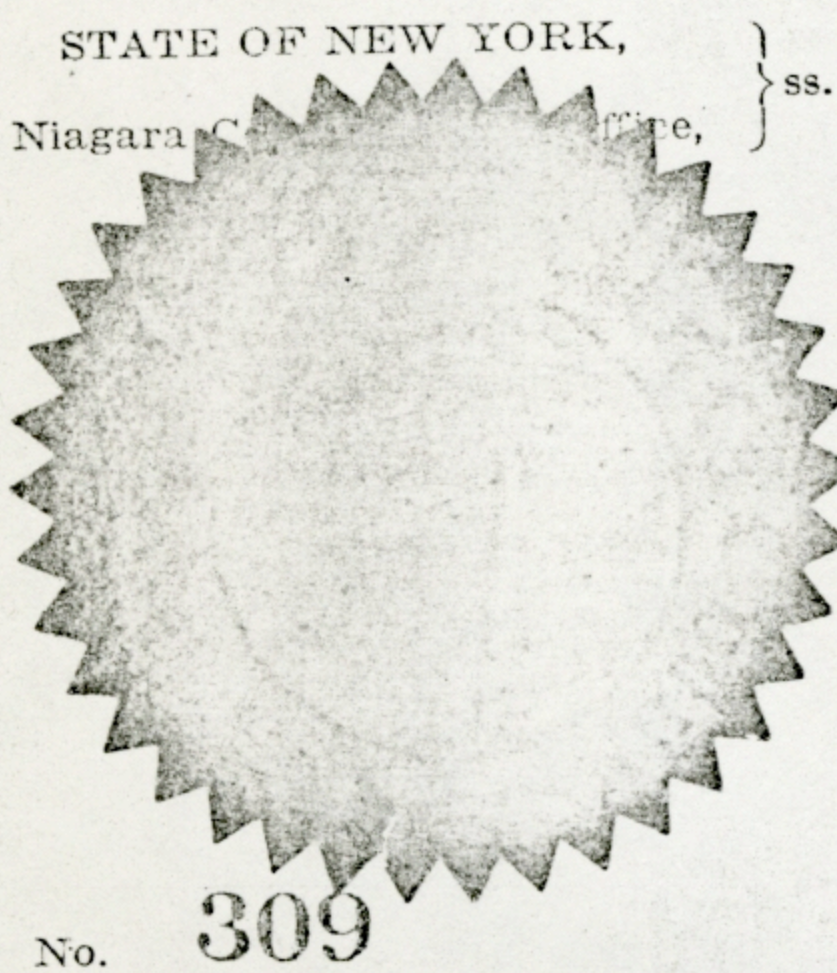
