Know All Men by These Presents, That the

First Baptist Church, Niagara Falls, New York

A RELIGIOUS CORPORATION, duly organized and incorporated under and by virtue of the laws of the State of New York, having its place of worship at the City of Niagara Falls, Niagara County, New York, hereby certifies, that it is indebted

unto

in the sum of

TWENTY-FIVE DOLLARS

for money loaned and advanced unto it, which amount it hereby promises, covenants and agrees to pay at its office in the City of Niagara Falls, Niagara County, New York, in ten years from the date hereof, on presentation and surrender of this Certificate, with the right, privilege and option, however, on the part of said Corporation to pay the whole or any part of the sum hereby agreed to be paid at any interest date prior to the expiration of said term of ten years, with ten days' prior notice, but not before the first day of June, 1951 and upon such payment in full to demand delivery and cancellation thereof.

AND until such indebtedness is fully paid said Corporation hereby promises, covenants, and agrees to pay interest on principal sum at the rate of three per centum (3%) per annum in lawful currency of the United States semi-annually on the first day of June and the first day of December of each year beginning on the first day of June of the year 1950 at the Office of the First Baptist Church, Main and Fourth Streets, Niagara Falls, New York.

THIS CERTIFICATE is transferable only on the books of the Corporation by the holder thereof, in person or by Attorney, on surrender of this Certificate.

IN WITNESS WHEREOF, the First Baptist Church of Niagara Falls, New York, has caused these presents to be duly executed for it and in its name by the Chairman of its Board of Trustees and its Treasurer pursuant to a resolution of the Board of Trustees of said Corporation duly adopted at a special business meeting of the said church held on March 15, 1950.
