# THE PARISH REGISTER

The Parish Register is the permanent, official record of the congregation. Properly kept, it is an essential historical and legal document, and serves a significant pastoral function as well.

The Parish Register is the property of the congregation, not of the pastor. If the pastor wishes to keep a personal record of such things as baptisms and weddings, this may, of course, be done; however, any such records are in addition to the official register of the congregation. The keeping of a Parish Register for each congregation served is a responsibility each pastor assumes when joining a synod and signing its Constitution and Bylaws. The keeping of personal records is an optional matter for a pastor; the keeping of the congregation's official record is required.

The Parish Register should be protected at least as well as an insurance policy or a bond. It should be kept in a fire-proof or fire-resistant safe, vault, or filing cabinet. Congregational leaders may wish to consider microfilming portions of the register or the entire "old" register when a new one is used.

If a congregation disbands, its Parish Register and any other official records should be placed in the synodical archives. Under no circumstances should such records be destroyed or be allowed to pass into private or secular hands.

The Parish Register should reflect at the end of each week the actual situation with respect to each member of the congregation. To postpone entries until enough are accumulated to make it "worthwhile" to enter them destroys the value of the Register and may result in an incomplete record due to lost or misplaced information. If at all possible, all entries should be made on the day of the relevant action or occurrence. Otherwise, should the pastor be incapacitated or suddenly leave the congregation, it might be extremely difficult or even impossible to find the needed information.

Furthermore, all entries should be complete; all required information should be properly recorded. All entries should be in ink, never in pencil. India ink is more nearly permanent than any other medium for writing, and is less likely to fade. Erasures should never be made in the Parish Register. An error should be corrected by drawing a line through it, re-entering the item correctly immediately above, and initialing the correction with the pastor's initials.

#### THE PARISH REGISTER

#### THE ROLL OF MEMBERS

This roll includes the names of all those holding membership in the congregation. Here should be entered the name of each person received into the congregation by one of the following methods:

- 1. Baptism;
- 2. Confirmation or affirmation of faith;
- 3. Transfer from another Lutheran congregation;
- Otherwise, including persons received from non-Lutheran congregations and from other sources.

Each member is assigned a Register Number which is never changed. The first name is number 1, and subsequent names are numbered consecutively as they are added throughout the history of the congregation. Thus, if 213 is the last number to be used, and the person having number 9 dies, a line is drawn through number 9 and it is not used again. The next person to be entered is assigned number 214. This Register Number is important because it is also listed before the name of the member in the Record of Communing and Contributing and/or in the Record of Communions; thus it serves as an aid in cross-referencing. Also, if used as part of a card or other filing system, it provides a ready lead-in from that file to the information in the register.

For high numbers, such as those above 9,999, other numbering systems are possible. Thus, instead of using 10,000, 10,001, etc., IA to 1,000A, 1B to 1,000B, etc., can be used as a way to avoid crowding the space provided for the Register Number.

When a new Parish Register is introduced to replace an old one, enter into the new register from the old one only the names of those persons who have not been removed from the Roll of Members, in numerical order, using the old Register Numbers. The numbers of members whose names have previously been removed from the roll should be omitted from the new Parish Register.

Names are removed from the Roll of Members in the following ways:

- 1. By death;
- 2. By transfer to another Lutheran congregation;
- Otherwise, including persons who joined non-Lutheran congregations and those removed for other reasons.

Detailed instructions for receiving and removing members are in the Instructions which accompany the annual congregational report forms. The most recent copy of these instructions should be kept with this Parish Register for ready reference.

In the Roll of Members, full information should be recorded about each member in the spaces provided. This includes the person's Register Number; full name, last name first; how received and removed and the date(s) for each; birth date and place; dates of baptism and confirmation, and the name and location of the congregation(s) where these events occurred; date of first Communion; date of marriage and to whom married. In the column headed M/F, enter M (male) or F (female) as appropriate. In the case of women who marry after their names are already on the roll, a line should be drawn through the Register Number of that person and the married name entered, using the same Register Number she had before.

The Confirmed column is left blank unless — or until — the individual is confirmed; a \( \sigma \) should then be entered. Counting the members not yet removed and noting the confirmed status of each is a convenient way to get summary data for the annual report form.

#### THE RECORD OF COMMUNING AND CONTRIBUTING

The information recorded here can assist the congregation in at least two ways. First, it will identify members who, as of any given time during the year, have responded to the Gospel by receiving the Lord's Supper and/or by making a financial contribution of record. Second, it will show which members have or have not met the church's requirement for being confirmed members in good standing.

The Register Number is the permanent number of the member obtained from the Roll of Members. The name should appear as it is in the Roll of Members, last name first. Identify confirmed members by a \( \sqrt{in} \) in the Confirmed column. Non-members who commune and/or contribute are not to be listed here.

Time will be saved in making entries if the initial listing is alphabetical. New members are added at the end of the roll. When the roll is transferred to new pages, it should be re-alphabetized.

A check mark ( \( \sqrt{} \)) will indicate a financial contribution of record and is entered only once each year immediately after the first such contribution. Similarly, such a mark in the Communing column, entered after the first Communion of the individual in the calendar year, provides the information needed with respect to the member's minimum participation in Holy Communion. However, a series of numbers (1, 2, 3, etc.), if small, can be entered in the Communing column, indicating the dates of the Communion services; thus, 1 = 1st Sunday in January; 2 = Ash Wednesday; 3 = Maundy Thursday. Other symbols and procedures may be used for the same purpose.

Names should be added to or removed from this record whenever appropriate. Removal should be indicated by drawing a line through the applicable Register Number.

#### THE RECORD OF COMMUNIONS

If only confirmed members are permitted to commune, the name of every confirmed member should be entered both in the Roll of Members and in this record. The name should appear exactly as it is in the Roll of Members, last name first. The Register Number should be entered in the column provided. The initial listing should be alphabetical. Names of additional confirmed members are added at the end of the list as they are received.

If unconfirmed members may commune, the names of all such persons eligible to receive the Sacrament at the time this list is made should be entered, along with the names of the confirmed members, the complete roster being alphabetized. Use a 
in the Confirmed column to identify confirmed members. As with the list of confirmed members, names of additional unconfirmed persons eligible to commune are added at the end of the list.

At the top of the page, the dates of the Communion services should be indicated, the year in the horizontal space and the month and day in the vertical spaces. Beside each name are spaces for recording the participation of each individual. When the list is transferred to new pages, it should be realphabetized.

Note: only members' communing records are kept here.

#### THE RECORD OF PASTORAL ACTS

Space is provided for recording baptisms, confirmations, marriages, and funerals.

All baptisms are to be recorded consecutively, last name first. Use the M/F column to indicate male or female. Names of persons baptized are entered simultaneously here and in the Roll of Members. The

date and place of birth and of baptism, the ifficiant, residence of parents, father's full name, nother's maiden name, and the names of the sponsor should all be recorded. Two additional columns make it possible to indicate by means of a vertica line or other symbol if the father and/or moner are members of the congregation. Names as never removed from the Record of Baptisms.

In the Record of Confirmations, the bllowing information is required: full name, last name first; dates of birth, baptism, and rite of confrmation; father's name and mother's maiden name; and officiant. No name is ever removed from this record. When a confirmation is recorded, lelevant information about the person confirmed should be entered on the Roll of Members, on the Record of Communing and Contributing, and on the Fecord of Communions.

Much of the information required for the recording of marriages is obtainable from the marriage license: the date and place of the marriage, names of bride and groom, their places of residence and their ages, names of witnesses, the number of the license (in places which issue numbered licenses) and the issuing authority, and the date when the completed license was returned. In addition, columns are provided in which can be indicated the name of the officiant, and whether or not the parties are members of the congregation. Some pastors have found it helpful in recording marriages to write the last name of the groom first, and to indent the name of the bride on the second line. Subsequent search for the record of a marriage is made much easier. The space provided for recording the date when the license was returned is important. There may be a penaltty for the late return of the form attached to the licemse. This column both reminds the pastor of this mætter and indicates that the return form was sent to the proper civil authority. No names should ever be removed from the Record of Marriages.

The Record of Funerals should be filled out in full. The information required includes: whether the deceased was a member of the congregation; full name; date and place of death; age at death in years, months, and days; date and place of the fifuneral or memorial service. The Remarks column mayy be used for additional information, e.g., officiant, pplace and date of interment. No names should ever be a removed from this record. If the deceased was a membber of the congregation at the time of death, a line i is drawn through the Register Number of that person and appropriate information entered in the I Removed column of the Roll of Members. Also, a line s should be drawn through the name of the deceased if it it appears

in the Record of Communing and Contributing and/or in the Record of Communions. An entry in the Record of Funerals of only the name of the deceased is not sufficient. Every funeral director should be told by the pastor what information is required for the records. If the memorial and burial services are held in different communities and/or by different pastors, the service conducted by the pastor of the congregation should be recorded along with all the other information, and a note made in the remarks column to the effect that the burial or memorial/funeral service took place elsewhere. All funerals conducted by the pastor(s) of the congregation should be recorded here, whether or not the deceased was a member.

#### THE HISTORICAL RECORDS

The historical dimension of the Parish Register can be provided effectively only if this section is properly maintained. The Charter of the congregation (either the original document or a certified copy) and the Constitution and Bylaws (the official copy) should be included. Space is provided for amendments.

The rolls of pastors and of church council members and officers are important parts of the congregation's history that are sometimes neglected. There is ample space for listing each pastor and his/her years of service, as well as each church council member and officer of the congregation and his/her term of office, position on council, and other leadership responsibilities.

The Annual Summary pages are for listing the essential items of information provided annually for the synod and the church-at-large. This record should be kept very carefully. It may seem that this is mere "busywork" since the congregation has a copy of each year's report forms, and much of the information appears in the minutes of the synod. However, loose copies of report forms are easily misplaced, and occasionally there are errors in published synodical summaries. When the needed information is entered annually in the Parish Register, the congregation has readily available to it an authentic and continuous record of its growth and development that is not available from any other source.

Events of historical significance in the congregation may be entered in the special section provided for them. Here should be recorded brief notices of anniversaries, installations of pastors, burning of mortgages, bequests, memorial gifts, additions of facilities and equipment, etc. This permanent record of matters of real significance may be the only source of such information in the future, when persons who now are aware of them are no longer available to share such highlights of the past.
