Born in Buffalo, the son of the founder of the city's first black-

owned hardware store, he was an inspector with the city Street Sanitation Department and later was a supervisor in the plates and mailing division for the Erie County Auto Registration Bureau. He retired in 1977.

His wife, the former Mary Francis King, died in 1974.

Surviving are two sons, John of Bridgeport, Conn., and Aaron; a daughter, Michelle Malone of Atlanta; a stepdaughter, Sharon Adams; nine grandchildren, and three great-grandchildren. He is also survived by his longtime companion, Deloris Melson.

She began playing organ for the youth choir and Sunday school classes and later accompanied the adult choirs and men's chorus. During her years as organist, she assisted not only First Shiloh but several other churches in the city, her family noted. In 1960, she was elected assistant music director of the Baptist Empire State Convention.

Dr. Myron McGuire, Dentist, Leader, Dies

Buffalo has lost one of its Black leaders. Dr. Myron St. Clair McGuire, 87, passed away in his home, 482 Jefferson Ave., Tuesday, Sept. 27, (1988) after a lengthy illness.

Funeral services were held Sat., Oct. 1st, at St. Michael's Roman Catholic Church, on Washington St.

Dr. McGuire was born on January 29, 1901, sixty miles from Buffalo, in Bradford, Pennsylvania. He lived in the Ellicott District since he came to Buffalo, at the tender age of eight. He graduated from Public School No. 32; Hutchinson Central High School (where he maintained an average of 96.4 and was awarded a scholarship from the "Douglas Club") an organization of Black women, which took care of his first year's tuition at the University of Buffalo.

He completed the University of Buffalo Schools of Liberal Arts and Dentistry. He graduated from the U. B. School of Dentistry, "Class of 1926. After graduation, he set up his practice in the Ellicott District, and remained there. His motto has been: "When adversity discourages you, do it anyhow."

Dr. McGuire served as a School Dentist in 1940, full and part-time in the Buffalo Health Department, which later became the Erie County Health Department. In 1977, he volunteered and worked to set up Neighborhood Dental Clinics as part of the Model Cities program and later became Assistant Clinical Director for the Erie County Dental Clinics. Under this title, he set up new dental clinics in School #53, with the assistance of Principal Nan Woods; and West Hertel Junior High School, with the assistance of Principal Gianturco.

Dr. McGuire was a member of the Erie County Dental Society; Council #84 Knights of Columbus; the University Club of Buffalo, The University of Buffalo Dental Alumni; The Upstate Medical Alliance, an organization of Black Professionals in medicine and the allied fields.

He was the founder of Phi Omega Graduate Chapter of the Omega Psi Phi Fraternity, Inc., a National fraternity with over five hundred chapters by districts throughout the United States; he was a member of the NAACP and a former member of the Board of Directors. During World War II, he worked closely with the executives of the local aircraft industries to place Black workers in jobs.

Dr. McGuire was the first Black in Buffalo, to be endorsed by a major political party for Councilman of the Ellicott District. Every Mayor since 1926, appointed him to a community board; housing boards, laboratory

boards, youth boards, etc. Under County Executive B. John Tutuska, Dr. McGuire was appointed Chairman of the Forensic Laboratory Board. Sister Mary Charlotte Barton appointed him to the D'Youville College Council.

Frank E. Merriweather, Sr., Editor and Founder of the Buffalo Criterion, was his political mentor and a friend until his death. He respected the Criterion for its long years of service to our community.

Dr. McGuire's wife, Neola McGuire, was an auditor for the County of Erie. She is now retired. She is a product of the schools of Buffalo, graduating from Public School #17; Hutchinson Central High School; Bryant & Stratton Business Institute; and also attended Canisius College, majoring in Accounting.

His daughter, Ellen M. Russell, is a graduate of the Meyer Memorial Hospital School of Nursing and

Lillian J. Meadows Dies; Was Advocate for Elderly

Memorial services will be held at 3 p.m. Wednesday in First Presbyterian Church, Symphony Circle, for Lillian J. Meadows, 73, a senior citizens advocate in Buffalo long before "aging" became politically popular, and whose untiring efforts in the field placed her in the Western New York delegation to the 1981 White House Conference on Aging.

Mrs. Meadows, an elder of the church and resident of Buffalo, died Wednesday (April 22, 1987) in Sisters Hospital, where she was a patient for three weeks.

Since 1959, when the late Buffalo Mayor Frank A. Sedita instituted special programs and special housing for the elderly, Mrs. Meadows was involved with Buffalo's senior citizens — first at the old Richard Carnevale Senior Citizens Center for 14 years, then at the Alfred D. Price Senior Citizens Center, in the Willert Park area, where she retired as supervisor in 1981.

Administration of those two offices and her personal drive to achieve dignity for old people resulted in her involvement with a number groups, organizations, agencies and individuals who helped her achieve that goal.

She was a contemporary of the Lucile M. Kinne, another area pioneer in programs for the aging and a member of the governor's committee that wrote the New York State charter for the aging.

Mrs. Meadows served on the State Committee on Aging, New York State Conference on Aging, the advisory committees on aging for both Erie County and Buffalo and the advisory board for the Older Americans Act Committee.

Mrs. Meadows was this area's first black to serve as a state Democratic committeewoman, a post she held for 30 years.

A member of the old Erie County Board of Supervisors, she got her start in government with the city's Board of Redevelopment. Positions followed in the Bureau of Vital Statistics, in the Common Council as aide to Councilman King Peterson and in the Recreation Department.

A native of Mobile, Ala., Mrs. Meadows came to Buffalo as child after her father, the late Sidney O. B. Johnson, was called to pastor the former Lloyd's memorial Congregational Church. The eldest sibling, she left Alabama's Talladega College in her junior year to help her

sick mother raise the younger children, including former Masten District Councilman Horace C. Johnson.

She was the widow of Isaac W. Meadows, a minority consultant for the New York State Employment Service.

She was a life member of the National Association for the Advancement of Colored People; served on the boards of the United Way, Travelers Aid Society, Allentown Community Association, and was a volunteer fund-raiser for the Heart Association, Cancer Society, Cystic Fibrosis Foundation and United Negro College Fund.

Among her numerous awards and citation Mrs. Meadows was the 1984 county nominee for state Senior Citizen, the initial inductee in the Buffalo Senior Citizens Hall of Fame and recipient of the 1978 Brotherhood Award for community effort from the National Conference of Christians and Jews.

Last November she received a special recognition for community service on behalf of the elderly from the Western New York Network in Aging, of which she was a charter member.

Surviving, in addition to the former councilman, are two sisters, Maggie J. Jones of New York City and Josephine J. Holmes; another brother, Charles R. Johnson, and nieces and nephews whom she raised, Beverly Johnson, the Rev. Paul E. Johnson of Montgomery, Ala., and Sidney F. Murphy of Jamaica, L.I.

Charles Michaux, 67, Dies; Was Active in Civic Affairs

A Mass of Christian Burial will be offered at 9:30 a.m. Tuesday in Immaculate Conception Church, 144 Edward St., for Charles L. Michaux, Jr., 67, a retired city official who spent 23 years in public service. Burial will be in Ridge Lawn Cemetery, Cheektowaga.

Michaux died Thursday (Jan. 23, 1986) in St. Joseph Intercommunity Hospital, Cheektowaga.

Michaux was long active in politics and community affairs.

He became Buffalo's first Parking Violations Bureau director in 1974. He entered public service in 1956 as the first black appointed to a permanent civil service position in City Court, where he served as a junior court clerk. He advanced to senior court clerk and then to principal court clerk. After four years as Parking Violations Bureau director, he returned to City Court until his retirement in 1979.

A Buffalo native, Michaux is a graduate of School 31 and the former Hutchinson Central High School. He received a bachelor's degree from the State University of Buffalo.

After retiring from City Court, Michaux continued graduate work in political science and began teaching part-time as an assistant professor at Erie Community College. He also was a senior instructor with the Erie County Department of Public Safety from 1973 until his death.

A veteran of Democratic politics, Michaux resigned in 1983 as party


chairman in Buffalo's 24th Zone, a post he held for 20 years. He was a former member of the Erie County Democratic Executive Committee for 15 years and a former Democratic committeeman for 25 years.

Michaux served in Italy during World War II, earning the Silver and Bronze stars, the Combat Infantryman's Badge and the Purple Heart. In 1950-51, he saw action in the Korean War as a general staff officer of operations and training. He retired in 1971 as a lieutenant colonel after 30 years in the Army Reserve and received the New York State Conspicuous Service Medal.

While active in many community affairs, Michaux received the Silver Beaver Award, the highest community award given by the Boy Scouts. Michaux made history with the Boy Scouts in 1932 as the first black Eagle Scout. He was a member of the executive board of the Boy Scouts of America, chairman of the council advancement committee of the Boy Scouts of America and local chapter chairman of the national Eagle Scout Association.

He also was secretary of the Buffalo Naval and Servicemen's Park board of directors. He was honored as a distinguished president of the West Side Kiwanis Club and distinguished past lieutenant governor of the New York State Kiwanis, Niagara Frontier West Division.

He also served on the congressional selection committee for all service academies. He was a past commander of Bennett Wells Post 1780,

American Legion, and past director of the Allentown Association. He was a member of the National Association for the Advancement of Colored People, the Urban League, the Retired Officers Association, the National Eagle Scout Association, and the Allentown Village Society.

He was the local chapter chairman of Judges and Police Executive Conference of Erie County, New York Inc., a member of the National Association of Court Administration, American Society for Public Administrators, Driver and Safety Educators Association of the State of New York, the American Judicature Society and the Police Studies Organization of the University of Illinois.

Survivors include his wife, Maria Rebasti Michaux; two daughters, Bruna Michaux and Ramona Draf-fin; two sons, Charles L. and John; two sisters, Joan Durant and Gladys Gowie, and five grandchildren.



Phil Muscato, highly ranked boxer in '40s

Phil Muscato, a Buffalo-born boxer who ranked fourth among world heavyweight contenders in the 1940s, was buried Tuesday in Holy Sepulchre Cemetery, Cheektowaga.

Muscato, 68, who drew thousands to Memorial Auditorium to watch him fight, died Sunday (July 7, 1991) in St. Joseph Hospital, Cheektowaga, after

a long illness.

Muscato earned more than \$100,000 in the 1940s battling such top-ranked fighters as Lee Oma, Joey Maxim, Lee Savold, Joe Matisi and Mickey Hayes.

In all, he had 79 professional fights and was known for his hard-hitting style that put many an opponent on the mat to the delight

of local fans. Muscato's last fight was May 3, 1950, in the Aud., where Nick Barone of Syracuse scored a technical knockout against him in the fourth round.

Muscato left boxing at age 27. While he never benefited from the money he earned in the ring, Muscato said in an interview 10 years later that he had no regrets.

"Sure I'm officially listed as broke. . . . but how can you say a man's broke who has a wonderful wife, three fine sons and the strength to work everyday?" he asked.

Muscato served in the Navy during World War II. After retiring from boxing, he worked for General Motors Corp. as a laborer.

Survivors include his wife, Anne; five sons, Michael and Chris, both of Las Vegas, Arky of Phoenix, Ariz., Mark and Jody, and eight grandchildren.
