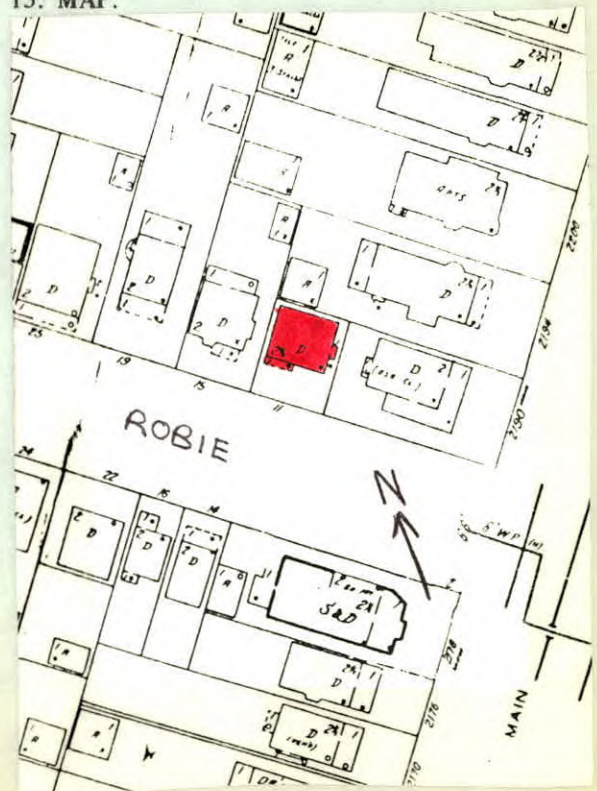

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a small sized corner lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story Queen Anne style. Side gable roof. Partial width pedimented gabled porch. Fluted Doric columns support entablature. Bowed stick balustrade. Aluminum door. Recessed first floor left bay has elliptical leaded window. Right bay has two-sided oriel with bracket support. Semi-circular tracery.

**SIGNIFICANCE** Center bay second floor has boxed bay with two double hung 1/1 windows. Cornice

19. DATE OF INITIAL CONSTRUCTION: c. 1900  
 ARCHITECT: small square lighted window. Large cross-gable through-the-cornice gable has two round arched windows, 1/1 lights. Right corner has semi-hexagonal two-story bay.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A fine example of Queen Anne style. Robie Street extends from Parkside Avenue to Main Street. Located in the center of the first section of the Parkside subdivision to be developed, on lands owned by Jacob Davis, Robie Street was deeded to the city in December 1887. Olmsted's early 1870's maps of "The Parkside" show a street angling from Humboldt to Parkside Avenue; however when Robie Street was laid out, it paralleled Humboldt Avenue. The street nevertheless still followed Olmsted's plan to have short cross streets in the subdivision, giving residents easy access to main thoroughfares and the park.
