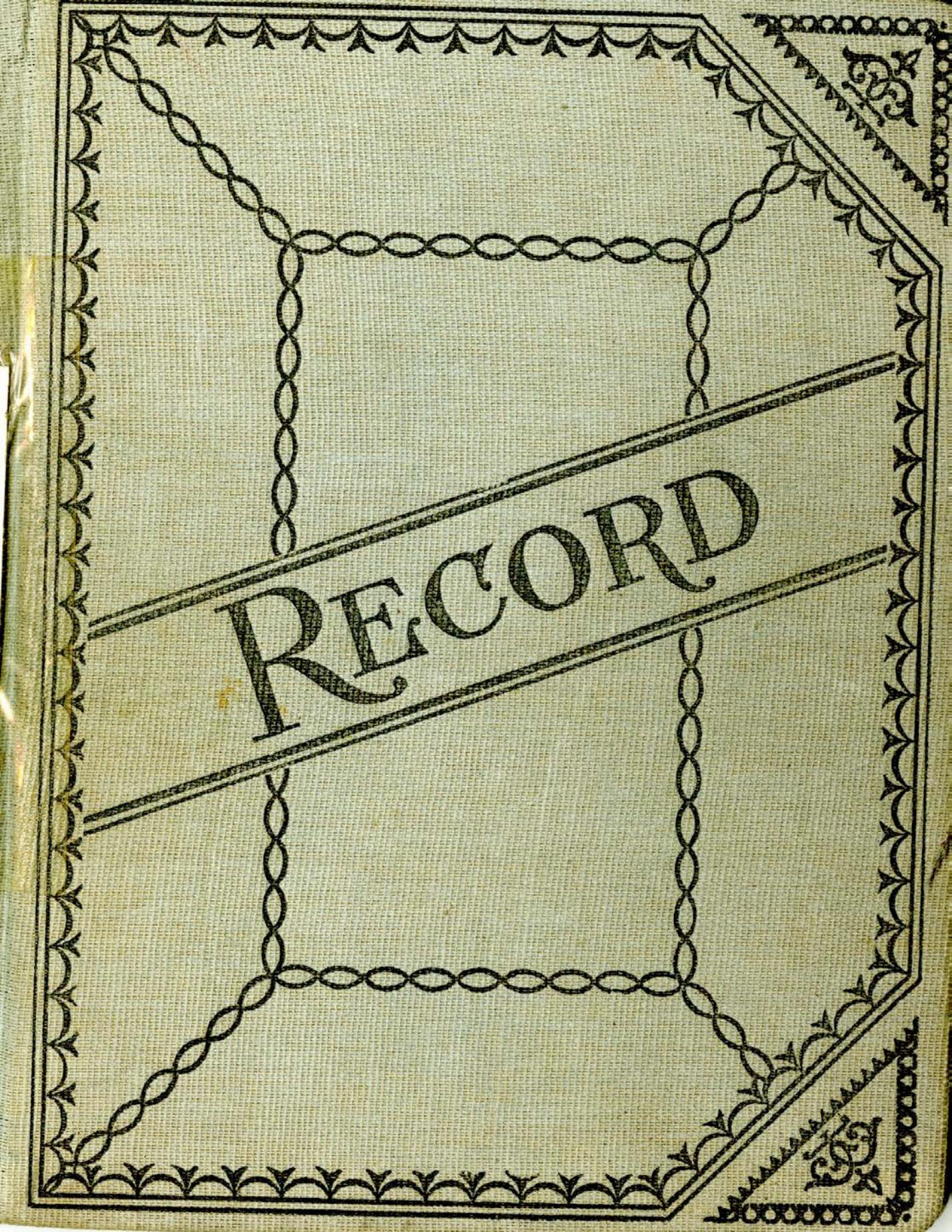

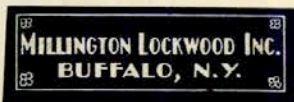

The Mission Committee met for the time to get organized
The ^{meeting} was held in the Church with Rev. A. L. Williams presiding
The following members being present Rev. A. L. Williams
Mr. Allinson, Mr. Connolly, Frank Hornsby, Samuel Jones
Fred Brown Sr. Edward Baker & the Clerk Mr. Lyall. Mr.
Taylor being out of town through sickness in family
The first Business attended to was the exact Status
of Edward Baker who had been elected as permanent
Alternate in case of absence of any member. It was
moved & unanimously carried that Edward Baker
sit at every meetings & take part in discussions
but could only vote when any member was absent
also he was entitled to act in any committee he may
be chosen for. The next Business was to Elect
a Financial Committee of Two (2) to act in conjunction
with Samuel Jones (Treasurer) as a permanent
Committee. It was Unanimously agreed that Fred
Brown Sr. & Mr. Taylor be appointed with Edward
Baker as Alternate. It was unanimously agreed that
we open an account with Power City Trust Co. (Pine
Ave Branch. Mr. Williams to arrange with Mr. Morrell
(Bank Manager) on Tuesday 15th about opening an account
Mr. Williams also agreed to Bank the money weekly as
none of the Financial Committee were free during
Banking Hours. It was Further agreed that the
Financial Committee keep the parish posted with
a monthly statement regarding the Financial
Condition of the Church either by Bulletin or post
a notice Prominent in Back of Church. The next

Business was the holding of the postponed Parish Meeting. It was agreed to recommend to Parish Council meeting Jan. 15 that the Annual General Parish meeting be held Monday Evening Jan. 28th 1935. To Elect a Clerk for a Term of three (3) years and to receive Annual reports from all Committees & Organizations & to transact other Business connected with Annual meeting. The meeting to be held under District Canon Law governing Annual Parish meetings. The Polls to open at 7.30 P. m & remain open for an hour or more according to Canon Law. A Financial report from Mr Thompson showed a Deficit of \$349-16 for year 1934. Owing to fact that Janitors salary has been cut down to \$12.00 & the Organist has donated her services \$126.00 will be saved in 1935. The next business was regarding a Bulletin Mr. William promised to issue a Monthly beginning 1st Feby if organizations will cooperate with him which was gladly promised. The matter of Evening communion was discussed & Mr. Williams promised to give it full consideration & if he thinks it advisable will arrange them as soon as possible as there was no further Business the meeting was adjourned.

Monthly meeting of mission Committee
Church of Redeemer

Feby. 12th 1935

The mission Committee met in vestry Rev. A. L. Williams Presiding. All members of Committee being Present except Wm Taylor who is out of town. Mr. Williams opened the meeting at 7.40 Pm with Prayer. The Clerk then read the minutes of the previous meeting there being no errors or corrections they were approved as read. The Treasurer then gave his report for January Received \$110.45. Disbursements \$88.65. Leaving a Balance \$21.80. Bills on hand not Paid Supplies \$9.24. Hefelfinger \$5.71. Coal Bill \$107.00. Total \$121.95. As many of these Bills had been carried over from last year it was moved & seconded that Mr. Williams approach St. Peter's Vestry to see if they would pay the Bills that were carried over. As it looked the income was not as good as expected & it was agreed to bring the matter of Finances before Parish Council so they would urge the members to greater efforts. As our Coal Bills seemed very high the matter was left in hand of Financial Committee to see what could be done about it. It was the opinion of the Committee that all organizations be urged to try & help more than they did last year as only one organization had been active along this line. Other organizations should not expect the Women's Aux to shoulder all the work now we are on our

own this matter was to be brought before all organizations at next Parish Council meeting. Mr Williams announced he was preparing the Lenten services & expected to have 6 speakers for Sunday Eve services & he would conduct the week day services himself. He also announced he was conducting one Evening Communion service a month to try it out. Mr Hornsby recommended that the week day services be held on Friday Evening instead of Thursday as it was last year he thought there would be more members come on Friday Evening. Mr Williams said he would be glad to consider any recommendation that would help the Church & would consider changing to Friday Evening. As there was no further business the meeting then adjourned.

Minutes of Meeting held Monday April 8th - 1935.

Meeting called to order by the Rev A. L. Williams at 8-p-m, those present were asked to rise for the benefit of prayer.

Minutes of previous meeting were now read, there being no errors or corrections to be made, they were approved as read.

The following members were present, A. L. Williams, M^{rs} Allinson, M^{rs} Connolly, Fred Brown Snr, Frank Hornoby, Edward Baker.

Edward Baker acted as clerk, on account of M^{rs} William Syall being absent.

The auditors report for the first Quarter was given by Edward Baker.

The sturdy memorial fund came up at this time and a brief discussion followed pro and con, after which it was decided to let the matter stand over, at the same time a motion was made & seconded that M^{rs} Patterson be asked to be present at the next regular meeting to enlighten us on the subject. (Carried).

M^{rs} Jones the Treasurer arrived at this time and gave his report, also made his report for the first Quarter, which tallied with the auditors report.

The work in regards to the Alter was then brought up again and it was suggested that M^{rs} Curry be taken up to St Stephens Church in La Salle to look at their Alter.

The next item was that in regards to the Parish Hall being used for to play basketball. It is not the damage to the windows alone, but also the wainscoting around the hall, the furnace and cupboards. Quite a discussion followed the sentiment of the meeting being that it should be abolished, seeing that there are so many other courts available for to train for basketball. M^{rs} Williams made a motion which was seconded, that unless those that use the hall for practice can prove that same is a real necessity, the practice will be abolished. (Carried).

Seeing that the Sunday following this meeting would be Palm Sunday, the question arose as to whether the children of the Sunday School would receive any Palm. It was the sentiment of those present that the children should have Palm and M^{rs} Williams stated that he would attend to the matter and also get Palm for the Alter, but there would be no flowers.

There was a brief discussion as to whether the Janitors services would be required

during the summer months, but nothing definite was decided on, it being thought that it could come up at the next regular meeting.

There being no further business to come before the committee, the meeting closed at 9-40 p-m.

Minutes of Mission Committee May. 13th 1935

The Mission Committee held its monthly meeting on above date in the Vestry Rm. A. L. Williams in the Chair. The meeting was called to order at 8.05 p.m. & was opened with Prayer by Mr. Williams.

The minutes of the previous meeting were read there being no errors or correction were approved as read. The following members being present Rev. C. H. Tyndell & Mr. Paterson from St. Peter's Vestry, Rev. A. L. Williams, Mrs. Allison, Mrs. Connolly, Mr. Fred Brown Sr., Mr. Sam Jones, Mr. Frank Hornsby, & the Clerk Wm. Pyall. Mr. Williams reported he had asked D. Tyndell regarding Sturdy Memorial Fund so D. Tyndell & Mr. Paterson had come to make a report on same & he called upon them for the information.

D. Tyndell said the Sturdy fund had been left to St. Peter's Vestry for the purpose of erecting & helping to maintain a mission. The sum of \$10,000

Ten Thousand Dollars being willed for that purpose over Twenty years ago. As St. Peter's Vestry has already spent over Twelve Thousand Dollars \$12,000 on the Building & maintaining the Church of Redeemer there was no more sturdy fund. Mr. Paterson, who had the Books with him agreed with D. Tyndell in his report. Mr. Williams on behalf of Mission Committee & Parish Council thank D. Tyndell & Mr. Paterson for their report as we the Mission Committee & Parish Council had never been able to get a report on the Fund & always had an idea there was still money in the Fund.

Owing to financial condition of the Church it was agreed to see various organizations at Parish Council to try & arrange to take care of Church during summer months under chairmanship of Mrs. Connolly with Mr. Brown & Hornsby assisting her & not pay for the janitor's services during June to September. Carried. Mr. Williams promised to see Mr. Curry about changing the Altar. Mr. Hornsby agreed to examine & overhaul Basement floor with Help. Mr. Brown spoke about the step on the sidewalk inside gate as it was very dangerous in the Dark. Mr. Hornsby agreed to see Mr. Noakes if sidewalk could be lifted and relaid without having the step in it. As there was no further Business the meeting was adjourned.

The Treasurer read his report up till June 1st as follows. On hand May 1st \$96.25 receipts for May \$84.65 Total \$180.90. Disbursements \$121.62. Balance on hand \$59.28. Unpaid Bills \$140.81 Leaving a Deficit of \$81.53 cents.

The report of the Variety Night Entertainment was then given by Wm. Smith. \$42.95 had been collected so far & \$4.50⁺ expenditure leaving a Balance turned over to Mr. Jones of \$38.45 cents. Mr. Jones also reported the Church Birthday Offering was \$6.11⁺. It was moved & seconded that the Financial reports be received & carried. It was moved that the money from the variety night be paid to the Coal Bill carried.

Mr. Williams announced that he had sent his resignation to St Peter's Vestry to take effect Aug 31st 1935. He said he had accepted a call from St Mary's on the Hill, Buffalo, & was to begin Duties Sept 1st 1935. It was agreed to ask the Parish Council meeting which was to follow that there be Volunteers to cut the grass with lawn mowers

sickles & a scythe, & Tools to pick up the weeds & same to be done on Wednesday Evening 12th - There being no further Business the meeting then adjourned to the Parish Council meeting.

A meeting of Mission Committee was held in the

 The minute of the Previous combined meeting of the
 Mission committee & Parish Council held on Nov. 5th
 & 10th were then read and approved as read.
 Under head of old Business Mr. Brown reported he had
 been unable to get full Particulars regarding the
 wire for Basement windows & asked for an extension

of time which was granted. The Treasurer then reported the Finance for Nov: On hand Nov. 1st \$15.07 Income for month \$109.00. Total \$124.07. Expenses \$90.77. leaving Balance \$33.30. Moved the report be received & filed Carried. Warden Frank Hornsby reported he had interviewed Mr. M. Daniels of St. Peter's Church regarding an organist for to replace Mr. Finn who is unable to carry on regularly. Miss Dovesmith was recommended & Mr. Hornsby talked with her & she agreed to become our organist & to receive \$6.00 per Month beginning after New year as she is to be married in Decr. The report being favorable to the Committee as it was felt we had to recompense the Organist being a stranger for her time. Moved & Seconded that Mr. Hornsby engage Miss Dovesmith on those terms Carried. Mr. Brown reported Mr. Stuart had examined the water system in the Church & had found leakage which may be cause of large water Bill Mr. Stuart Fixed the leakage now so everything should be alright. It was recommended that a Key be given to Water Company so that regular Quarterly readings be taken. Moved & Seconded the report be received & a Key be given Water Company Carried. The ^{clerk} reported he had written to Diocesan Mission Committee & received permission to go ahead with wiring of windows. He also reported he had written City Manager

regarding police protection but had received no word. Mrs. Allinson reported she had talked with Dr. Mosher regarding Prayer & Hymn Books. There were no Prayer Books on hand at present & Mrs. Allinson asked for an extension of time which was granted. The matter of Girls Scouts was then discussed. The committee were in favor of a Girl Scout Troop provided that the leadership, Hours & time could be favorable agreed upon. Carried. Under head of New Business Dr. Peckham asked to bring some very important matters up if other members had finished. Dr. Peckham asked for Value of Church property. The Clerk was instructed to get same. The Clerk was also instructed to write Miss Bartlett, Bishop's Secretary to have her send the the Confirmations Certificates to Dr. Peckham so he will distribute them to last Confirmation class. Dr. Peckham then spoke about Church Register. As the Register was in such a condition it was a hard job to get information in a hurry & as the register was almost full Dr. Peckham recommended we buy a new register & service Book which was better suited & more up to date. The register is sold by Jacobs & Co. \$3.00. Moved & Seconded the new register recommended by Dr. Peckham be purchased. Carried. Dr. Peckham spoke about Index Cards & Filing case he had purchased & had Typed. Moved & Seconded Dr. Peckham be reimbursed for expenses for Filing system Carried.

D^r Peckham then spoke about a clock for choir room as there was always some confusion in choir room as no one knew time. Moved & seconded M^{rs} Connolly he appointed as a committee to purchase clock price not to exceed \$2-50. D^r Peckham then spoke about keeping the Church Records & Communion set safe he recommended we purchase a safe he thought we required one & that we might get a second hand one cheap. Fred Brown was appointed as a committee of one to try & price & if one could be purchased for \$10.00 or less he was to same. Carried. D^r Peckham then spoke about holding a pastor's night he explained that various organizations could sponsor same. D^r Peckham would allow \$1.00 to the organization for a light refreshment. The sponsors had to serve the lunch & arrange programs. The Pastor would speak on some subject for about 20 min then a period of general Discussion & Questions then the Pastor would have another period then sponsors would have charge. D^r Peckham said there would be about 8 meetings a year & his Subject would include matters every Church members ought to know. The Clerk asked about annual Parish meeting. D^r Peckham said since we were now a Diocesan mission it probably would be best to write Bishop Davis explaining our set up & asking permission to hold our meeting under present set up or have the Bishop recommend some other set up to conform with Canon Law. The Committee accepted D^r Peckham's advice & instructed the Clerk to write

Bishop Davis for his opinion carried. The Warden Frank Hornsby spoke about the condition of the numbers on the Service sign Board it was almost impossible for those at Back of Church. Moved & Seconded Warden purchase new numbers at a cost of about \$2.00. Treasurer Samuel Jones asked if any word had been received from Police Department regarding tools stolen as no word had been received it was moved & seconded Mr. Hornsby be reimbursed \$10.00 for loss of tools. Carried. There being no further Business the meeting then adjourned.

It was also reported that a key of the church had been given to the city water department, so that they could gain admission to the church to read the water meter.

M^{rs} Allinson reported on the Hymnals & Prayer books, stating as before that there was no funds available for to purchase same. A letter with the address where books can be obtained was handed to the clerk pro-tem to be kept for future reference.

M^{rs} Hornsby had nothing definite to report regarding the safe.

M^{rs} Allinson reported as to the Girl Guide movement, stating that the requirements necessary, so far had not been complied with, and the request for the troop was ordered disbanded with for the time being.

Art 3. The membership of the Council shall be Two (2) Representatives from the following organizations: Mission Committee, Women's Auxiliary, Altar Guild, Church School, Choir, Young People's Fellowship, and 1 representative from Boy Scouts, & Dramatic Club. And the Pastor of the Church.

Art 4 The Officers of the Organization shall be: Chairman & Secretary.

The Chairman shall be the Rector of the Parish
 The Secretary shall be Elected by Ballot to serve a Term of One (1) year. Term of Office shall begin immediately after Election
 By Laws.

1. The Council shall hold one regular meeting every
2. The Chairman shall have the power to call special meetings
3. A special meeting may also be called upon the request of a majority of the members.
4. Five members shall constitute a Quorum
5. The Rector shall preside at all meetings of the Council. In the absence of the Rector the Warden shall preside.
6. The Secretary shall keep the minutes of all meetings. The record of name & addresses of all members and be the custodian of all Council records & correspondence. Moved & Seconded the communication be received & filed & two representatives be appointed. The Chairman

appointed Warden Fred Brown & Treasurer Samuel Jones to represent Mission Committee on Parish Council. The Chairman of Financial Committee reported there would be a shortage of about \$300. for the Budget & recommended a sub canvass on those members who did not pledge or having fallen down on their pledge to see if we can reduce the deficit. M^r Brown as Warden and Building Committee Chairman gave a report on all the work done and under way by his committee which had included the painting & repairing the outside of Building, repairing the Basement floor and he said he expected to have the Chancel floor & furniture all renovated before the end of the year. He also reports that the \$200.00 Dollars raised for this work had been used up and a small sum had been granted by the mission committee to complete the work. \$10.00 had been granted by the Altar Guild for the renovating the Chancel. The report was received & filed at this time D^r Peckham announced a letter had been received from Bishop Davis commending the Parish on the work done. The Bishop said he did not know that \$200.00 could go so far & praised the members for their voluntary work. D^r Peckham then asked for organization reports M^{rs} Stuart Aux Treasurer reported as follows Balance from last year \$92.48 income for year \$186.37. Total income \$278.85 Expenditure \$185.55. Leaving a Balance of \$93.30. This makes a Profit for year of 82 cents. The Aux gave to Church Treasurer \$125.00, and spent \$31.65 for material to cover the Church Seat cushions. The rest

of the money was spent mostly on mission work. Mrs. Myers then gave a report of all the work and activities of the Aux which showed the Aux to be very active on missionary work as well as very active in the Church. Dr. Peckham highly commended the Aux in their work especially the missionary work. Moved & Seconded both Aux reports be received and filed. Mrs. Connolly Treasurer of the Sunday School then gave her report as follows Balance from last report \$57.22 income for year \$161.03 making a total of \$218.25. Expenditure for year was \$187.75 leaving a Balance of \$30.50. of the Expenditure \$80.54 was for Curriculum, Donation to Church \$35.00 and the rest was for various items including the Expense from Picnic, Christmas & Halloween Parties, Organist Salary, screens for Deviding Classes, Blackboard, Flowers Postage and Communion Breakfast. There is also a Deposit of \$36.69 in Defunct East Side Bank. As Mrs. Lyall School Secretary had no report ready a motion was made & carried that Treasurers report be received and filed. Janet Lyall reported on activities of the Dramatic Club. Since the Club was organized Feb. 1936. There has been two Plays dramatized "Deacon Dubbs" was played June 4 & 10 1936 and was repeated in conjunction with Daughters of St. George on Feb. 4 & 5 1937. On Nov 17 & 18th the Play "Mary's Castle in the Air" was presented & was even more successful Dramatically & Financially than the First Play. The funds of the Club now in the Bank are at the Disposal of the Church Building Committee when ~~there is~~ a necessity arises. The Club also had 4 Dances the proceeds of which are going toward a new curtain

for the stage. The Club is now working on the Parish Bazaar & are making plans to help some needy family during Christmas. Jean Carter Treasurer of the Club then reported finances as follows. Total Income \$111.13. as follows. 1st Play Proceeds. \$33.82. 4 Dances \$15.25. Dues - 45[¢] Proceeds 2nd Play Nov. 17 & 18. \$61.61 Expenditure \$36.73. as follows to Church funds \$30.00. Dance Expense \$2.38. Flowers 75[¢], Liquor \$3.60. Leaving a Balance \$74.40[¢]. Moved & Sec. the reports be received & filed and dramatic Club be commended on their fine work. Janet Lyall then reported on activities of the Altar Guild. Mrs. Wakefield, the Choir Mother, is a Honorary Member. Mrs. Baker and Mrs. Connolly are Advisers and Mrs. Baker also has charge of the flowers on the Altar. The Guild takes care of the Altar & Sanctuary. The Minister's Vestments & Buys the wine & wafers for the communion from funds received from Communion Service. The Guild has asked the Building Committee under Mr. Brown to renovate the Floor & Furniture of the Sanctuary and expect it done before Christmas. They are also working on the Parish Bazaar Program. As Grace Baker Guild Treasurer was absent there was no Treasurer's report. A motion was made & Seconded that ^{Secretary's} report be received & filed. Mr. Hornsby reported on the Choir. Mr. Templar is Choir Organist and Mrs. Wakefield Choir Mother. He reported the Organ had been Tuned & was now in good condition. He said the Choir needs more members he also spoke about the long faithful service of Mr. Colchun and one or two others. Mr. Colchun had been very faithful for about 16 years. Dr. Peckham asked Mr. Hornsby to get the data of the Song Service members

so he could commend them on their Faithful Service
 A motion was made & Carried the Report be received & filed
 Mr. Brown Scoutmaster reported on Scout Activities
 the membership was 24 and 14 Boys were getting Boys life
 magazine. The Boys Pay 5¢ a week this pays for their
 registration Etc. The Troop had been making rapid advancement
 and were considered one of the best in the City. 63 per cent
 of the Boys belong to our Church. Some of the boys were
 problem Boys sent to our Troop by the social agencies
 of the City but they were all making good so far.

Brown moved that if there was any money in Treasurer the coal Bin be filled up carried as there was no further Business the meeting was adjourned at 10-40 P.M. with prayer.
