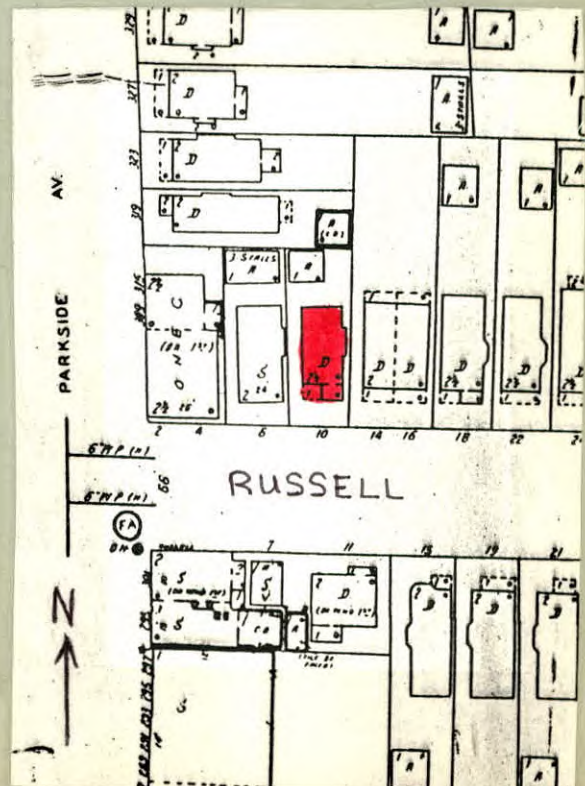

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located one block from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
 Two and a half story frame residence. Front facing gable roof. Full-width flat roof porch partially enclosed. Eave overhang. Corner square doric support. Spindle balustrade. Aluminum storm door. Two sets of paired casement windows, 4 lights each with two-light transom. Second floor right bay has semi-hexagonal bay.

SIGNIFICANCE Double hung 1/1 windows. Glass and wood paneled porch door. Plain surrounds. Band of trim below extending eave of pedimented gable. Shingled gable. Paired double-hung 1/1 window.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical frame residence found throughout the Buffalo area. Russell Avenue extends from Parkside Avenue to Greenfield Street. It was laid out in a map of 1886, paralleling the northern border of the lands of Washington Russell, after whom the street was named. However it was early 1889 before Russell Avenue was deeded to the city. While this particular street does not appear in Olmsted's early 1870's maps of "The Parkside," Olmsted felt cross streets would allow easy access to major thoroughfares and to the park, and he did include similar cross streets such as Jewett Avenue in his early plans.
