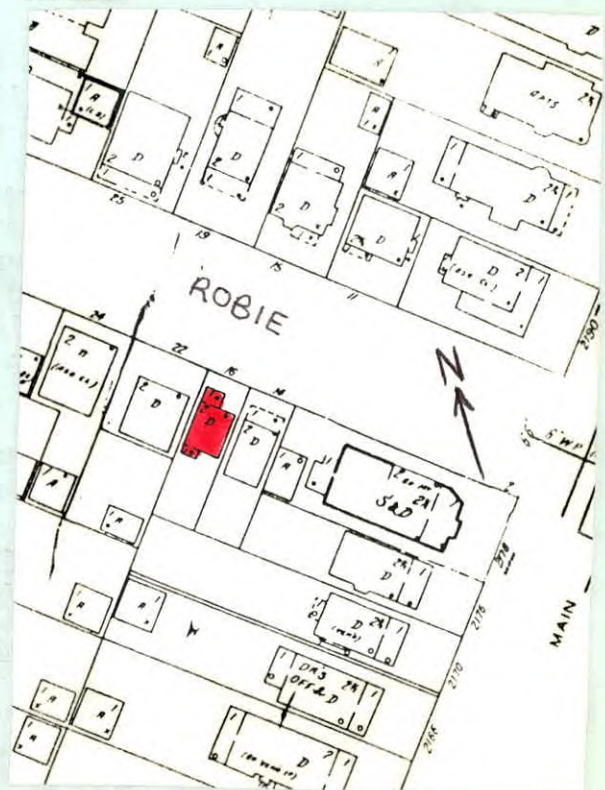

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story frame residence. Side gable roof with cornice end returns. Partial width hip roof porch. Engaged Doric columns at ends of porch. Two 4-light windows. Left side has aluminum door. First floor left bay has single-hung window; single light with leaded top light. Second floor has two 8/1 windows. Plain window surrounds. Corner boards.

19. DATE OF INITIAL CONSTRUCTION: c. 1900 Two flat-roof dormers have two 6-light casement windows each.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A simple frame residence with Colonial Revival details. Robie Street extends from Parkside Avenue to Main Street. Located in the center of the first section of the Parkside subdivision to be developed, on lands owned by Jacob Davis, Robie Street was deeded to the city in December 1887. Olmsted's early 1870's maps of "The Parkside" show a street angling from Humboldt to Parkside Avenue; however when Robie Street was laid out, it paralleled Humboldt Avenue. The street nevertheless still followed Olmsted's plan to have short cross streets in the subdivision, giving residence easy access to main thoroughfares and the park.
