

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS: (Indicate if building or structure is in an historic district)

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located four blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known): Two and a half story frame with steep pitched front-facing gable. Full-width shed roof porch. Pediment over left side. Doric column supports. Three-light wood paneled door. Left bay first floor has double-hung 1/1 window. Right bay has double-hung 1/1 window. Second floor has two semi-hexagonal bays. Sides of bay have double-hung 1/1 windows. Pedimented gable has paired double-hung windows. Radiating tracery in top light. Entablature window

BUILDER: gable shingled. Round arched panel with sunburst design.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A simple version of a Queen Anne style. Similar to 24 Elam Place in building plan. Elam Place, a one-block street between Crescent Avenue and Greenfield Street just north of Jewett Parkway, is located on the lands of Elam R. Jewett and was named after him. It was deeded to the city by his widow in 1889. A similar street appears on Olmsted's early 1870's maps of "The Parkside," although that street was angled to connect Greenfield with the intersection of Crescent and Jewett. Elam Place also follows Olmsted's rule that a subdivision street "not lead with special directness toward the town."
