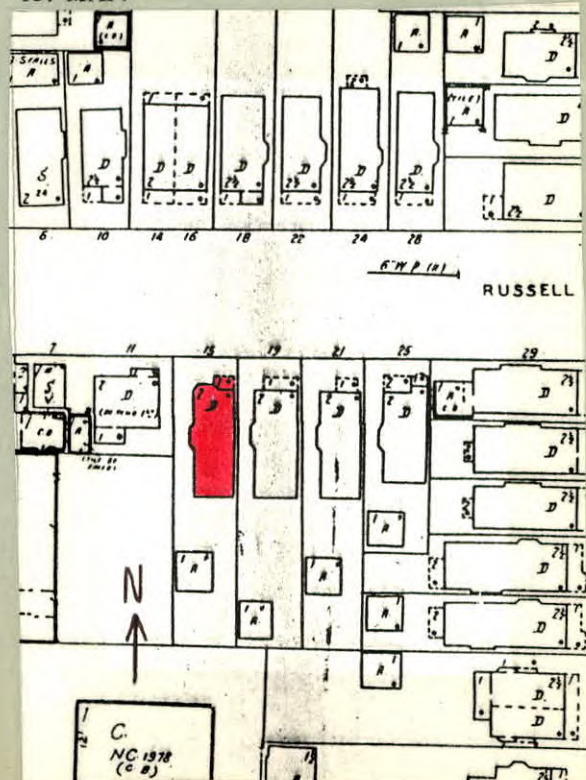

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located one block from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story frame residence with Prairie School style influence. Hip roof with brackets under front eave. Partial width flat roof porch with eave overhang. Rough cut, regular course stone base. Square Doric supports. Spindle balustrade. Glass and wood paneled door with 6 light sidelights. Weatherboard **SIGNIFICANCE** on first floor. Two story semi-hexagonal bay on right side of front facade.

19. DATE OF INITIAL CONSTRUCTION: 1914

ARCHITECT: windows with 9/1 sides. Double sash lighted porch door. Clapboard second floor. Hip roof dormer with brackets under eave. Three 9-light windows.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A double frame residence with Prairie School styling. Russell Avenue extends from Parkside Avenue to Greenfield Street. It was laid out in a map of 1886, paralleling the northern border of the lands of Washington Russell, after whom the street was named. However it was early 1889 before Russell Avenue was deeded to the city. While this particular street does not appear in Olmsted's early 1870's maps of "The Parkside," Olmsted felt cross streets would allow easy access to major thoroughfares and to the park, and he did include similar cross streets such as Jewett Avenue in his early plans.
