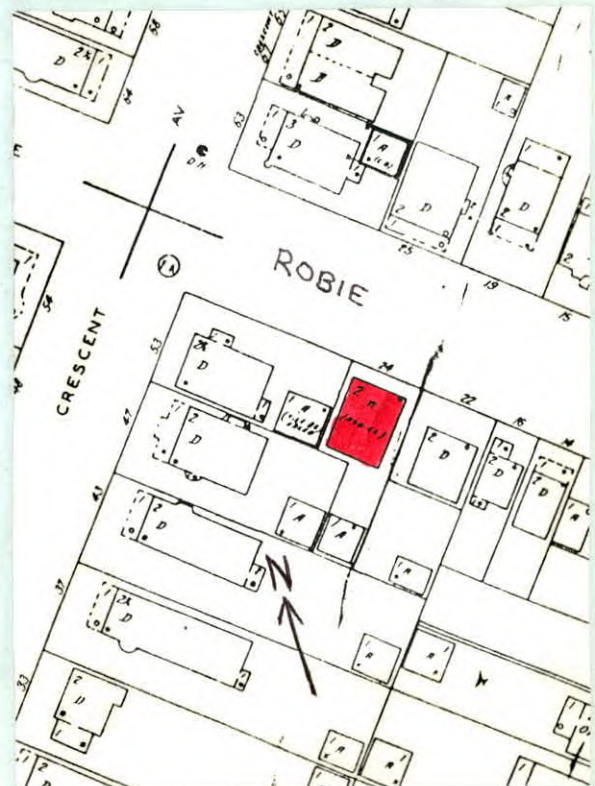

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two story frame with side gable roof. Right bay first floor has single-hung single light window flanked to left by 9-light wood paneled door. Moulded surround. Metal hip hood. Left bay has lighted wood paneled door with metal hip hood. Moulded surround. To right of this entrance is a semi-hexagonal oriel. Double hung 9/9 windows. Plain window surround.

SIGNIFICANCE

19. DATE OF INITIAL CONSTRUCTION: c. 1894 Console brackets under roof eave. Polygonal dormer.
 ARCHITECT: Center double hung window with vertical and horizontal border in top light. Sides have
 BUILDER: rectangular single light windows. Shed roof dormer has rectangular window with double bordered lights.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: The house typifies a simplified Queen Anne form with later additions. Robie Street extends from Parkside Avenue to Main Street. Located in the center of the first section of the Parkside subdivision to be developed, on lands owned by Jacob Davis, Robie Street was deeded to the city in December 1887. Olmsted's early 1870's maps of "The Parkside" show a street angling from Humboldt to Parkside Avenue; however when Robie Street was laid out, it paralleled Humboldt Avenue. The street nevertheless still followed Olmsted's plan to have short cross streets in the subdivision, giving residents easy access to main thoroughfares and the park.
