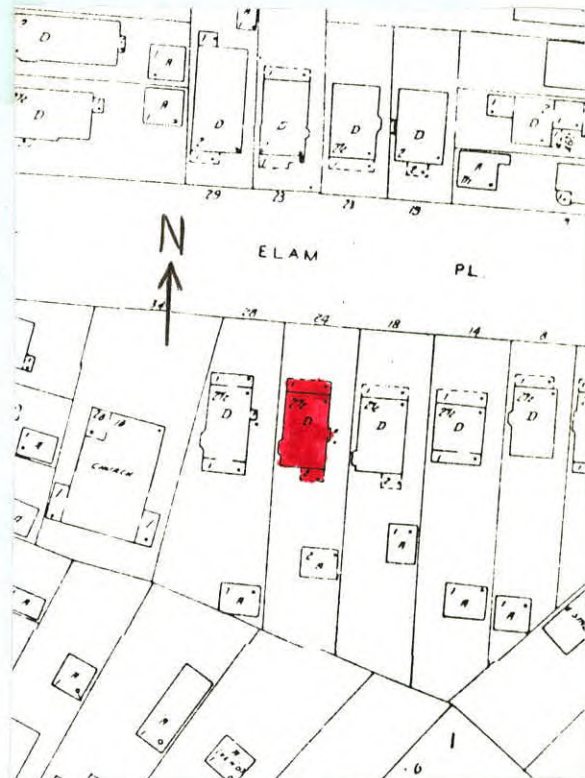

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located four blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story frame with steep pitched front-facing gable roof. Full-width shed roof porch. Pediment over left side. Tympanum decorated with leaf and vine motif. Glass and wood paneled door. Left bay first floor has double-hung 1/1 window. Right bay has paired double-hung 1/1 windows. Second floor has two semi-hexagonal bays. Sides of bays have double-hung 1/1 windows. Plain

SIGNIFICANCE

19. DATE OF INITIAL CONSTRUCTION: 1903
ARCHITECT: trim below gable eave. Pedimented gable with paired 4/1 windows. Entablature window head spans top of gable. Semi-circular panel in top of gable. Sunburst design.
BUILDER: _____

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A simplified form of a Queen Anne style. Similar to 18 Elam Place in building plan. Elam Place, a one-block street between Crescent Avenue and Greenfield Street just north of Jewett Parkway, is located on the lands of Elam R. Jewett and was named after him. It was deeded to the city by his widow in 1889. A similar street appears on Olmsted's 1870's maps of "The Parkside," although that street was angled to connect Greenfield with the intersection of Crescent and Jewett. Elam Place also follows Olmsted's rule that a subdivision street "not lead with special directness toward the town."
