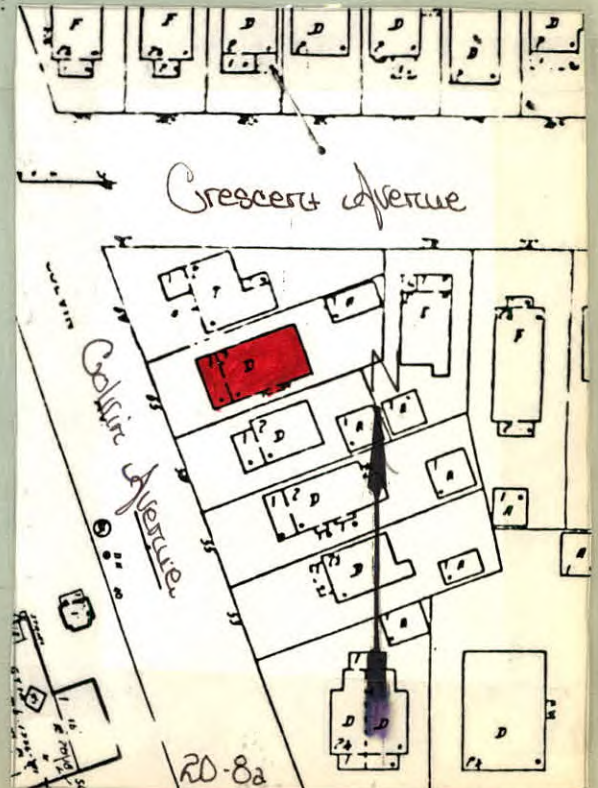

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:  
 (Indicate if building or structure is in an historic district)  
 The building is situated on a standard size building lot in Olmsted's Parkside subdivision. The north-south thoroughfare at its most southerly end runs directly into the grounds of the Buffalo Zoological Society. The Nichols School athletic field is located on the west side of Colvin.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):  
 Two and one half story with Craftsman detailing. Front facing gable roof with projecting eaves. Full length pedimented gable, enclosed porch has rough cut irregular coursed stone piers and railing. Horizontal band of windows, single light with transom. South entrance porch has hip roof. Glass and wood paneled door. Second floor has a set of paired square-headed windows, single light positioned under eave and at building ends. Gable has tri-

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:  
 Colvin Street takes its name from Peter Colvin, a Holland Land Co. Agent. In the 1890's the street was known as Niagara Blvd. and Niagara Falls Blvd. Colvin is a Zoo entrance from the north. It relates directly to Olmsted's 1876 Sketch Map of the Park System. The land was part of a subdivision named "Meadow View Park" conveyed to George L. Thorne and Byron Angell in July 1889 by James Tillighast. The restrictive covenants in the deeds of sale to subdividers provided for residential use only, and said dwellings "shall all be of ...tasteful design."
