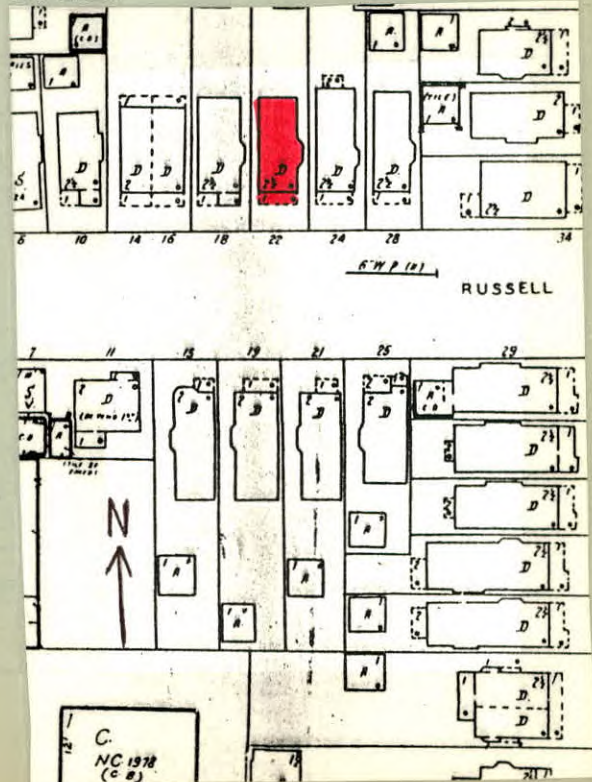

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located one block from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story frame with front facing gable roof. Full-width flat roof porch with eave overhang. Glass paneled door with 3/4 opaque glass sidelights. Three-part first floor window. Single light center with double-hung 1/1 sides. Second floor semi-hexagonal bay with double hung 1/1 windows. Lighted porch door. Plain window and door surround. Fluted Doric end pilaster strips.

19. DATE OF INITIAL CONSTRUCTION: 1910

Modillion style brackets

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical frame double residence found throughout Buffalo. Russell Avenue extends from Parkside Avenue to Greenfield Street. It was laid out in a map of 1886, paralleling the northern border of the lands of Washington Russell, after whom the street was named. However it was early 1889 before Russell Avenue was deeded to the city. While this particular street does not appear in Olmsted's early 1870's maps of "The Parkside," Olmsted felt cross streets would allow easy access to major thoroughfares and to the park, and he did include similar cross streets such as Jewett Avenue in his early plans.
