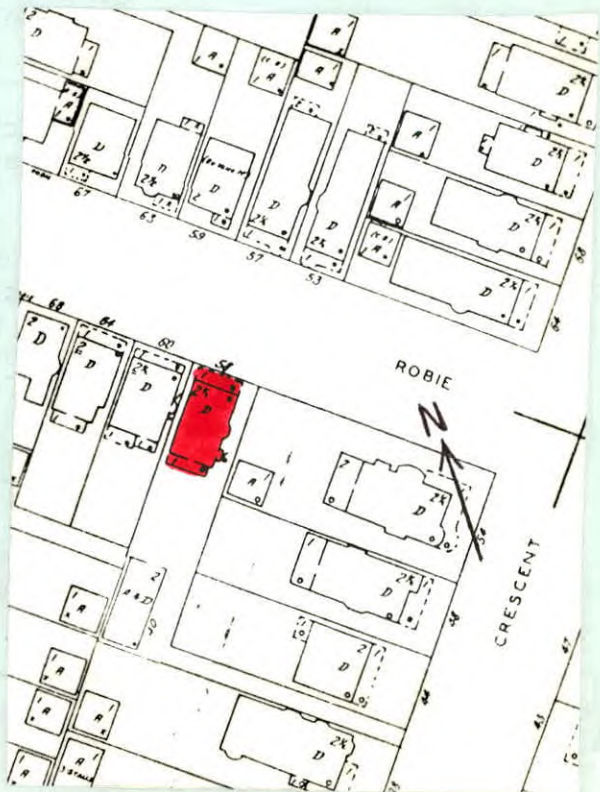

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story Colonial Revival style. Steep-pitched hip roof with paired curved brackets under eave. Full-width flat roof porch with eave overhang. Shingled base. Square Doric supports and stick balustrade. Glass paneled door flanked by double-hung 1/1 windows. Second floor has two bowed bays. Single hung windows with leaded glass top lights. Fluted apron. Band of

SIGNIFICANCE trim above windows decorated

19. DATE OF INITIAL CONSTRUCTION: c. 1905

ARCHITECT: fluted Doric pilasters. Hip roof dormer, whose roof is an extension of the roof proper. Two double hung 1/1 windows with diamond-shaped leading in top light.
BUILDER: Band of trim below eave decorated with garlands.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A good example of Colonial Revival style with Classical details. Porch is a later addition. Robie Street extends from Parkside Avenue to Main Street. Located in the center of the first section of the Parkside subdivision to be developed, on lands owned by Jacob Davis, Robie Street was deeded to the city in December 1887. Olmsted's early 1870's maps of "The Parkside" show a street angling from Humboldt to Parkside Avenue; however when Robie Street was laid out, it paralleled Humboldt Avenue. The street nevertheless still followed Olmsted's plan to have short cross streets in the subdivision, giving residents easy access to main thoroughfares and the park.
