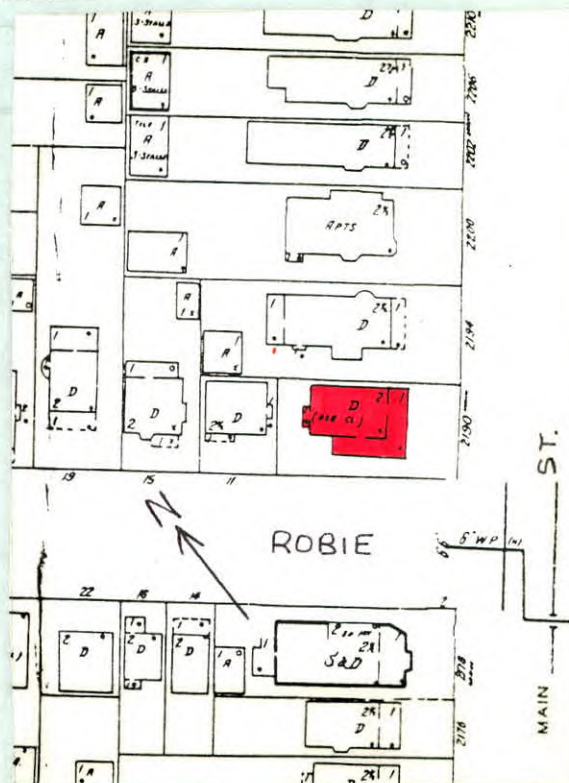

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story frame with front facing gable roof. Flat-top hip roof spans first floor. Two three-part double hung 1/1 windows on first floor front facade. Second floor has two 1/1 windows. Pedimented gable has three-part window, single lights with arched tracery. Entablature window surround. South side has pedimented gable entrance porch, enclosed. Glass paneled

19. DATE OF INITIAL CONSTRUCTION: 1900 door with sidelights. Cross gable dormer on south side has Palladian window.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A gabled frame residence with Classical details applied to building. Originally the Buffalo and Williamsville Macadam Road, Main Street was a pre-existing street at the time Olmsted designated it as the eastern border for "The Parkside." While the streets within the subdivision were designed specifically to avoid commercial development, this portion of Main Street became a combination of commercial and residential structures. It was also a major thoroughfare into the city, allowing easy access to downtown from this suburban neighborhood.
