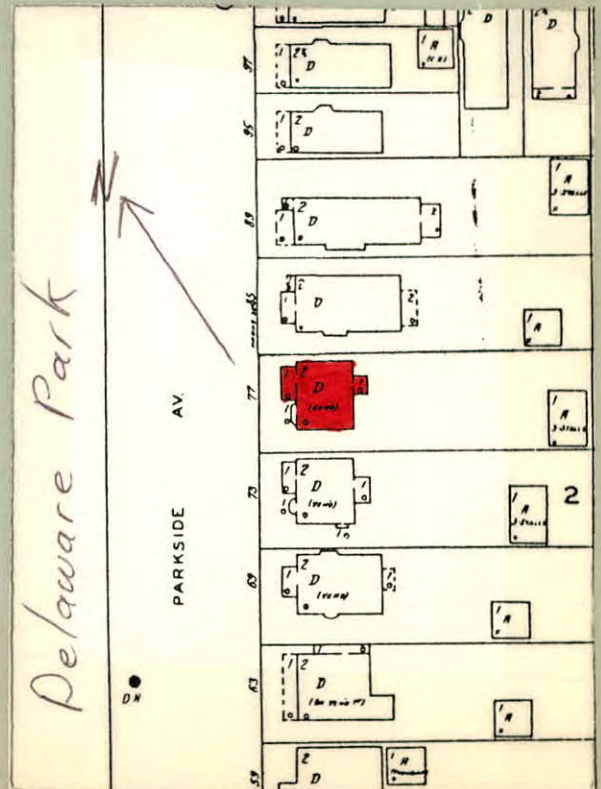

Two story American Four Square with Gothic revival styling, Hip roof and gabled dormers on the west and south facades. Notable features include an enclosed crenelated sunporch on the west facade and a projecting two story bay with leaded glass windows on the west facade. 20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:
18. wood moulding enframement. A large decorative window is located at the second story level of the north facade. First floor is brick veneer.
20. Unique example of the American Four Square as it was built in this neighborhood. This house is located on Parkside Avenue, a street conceived by FLO around 1873 as part of a residential "suburb" adjacent to Delaware Park. This suburb was called "The Parkside" by Olmsted and appears on an 1876 map drawn by him as a proposed area of curved winding streets on the north and east sides of the park. Parkside Avenue was actually created by the City of Buffalo in 1888. The street very closely follows Olmsted's original plan
