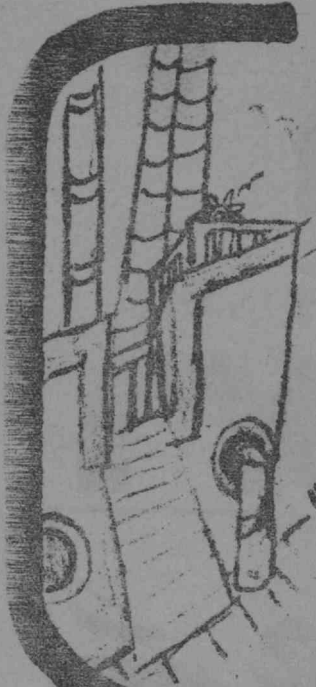

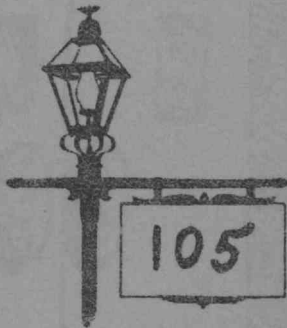

THE BAR ISSUE by Don Michaels

The gay bar situation in Buffalo has never been good. Whenever a new bar opens, the first question in everyone's mind is "How long will it stay open?" The Vice Squad and the S.L.A. have closed so many gay bars in the past several years that it seems like they're playing a game of musical chairs.

Mattachine has, in the past, taken a "hands off" attitude toward the problems of the bars. However, it is now apparent that due to the backward policies of the Buffalo Police Vice Squad and the State Liquor Authority, an atmosphere has been created at the gay bar level that is clearly oppressive to any gay person that wishes to use the bars to give expression to their social needs. Bar closings by Vice Squad/S.L.A. actions and subsequent overreaction by other bar owners to these closings, by instituting policies of 'no touch-no slow dancing,' has created an intolerable situation for all of us.

Concern and indignation has mounted to the point where a group of us in Mattachine met to discuss the situation and determine what we, as an organization, could do to correct it. It was determined that what was needed was a definite statement of what the gay community would feel comfortable with as basic policy guidelines for bar owners. We felt that if bar owners were going to benefit as business people from what is essentially a 'captive' clientele, they should be willing to help create a freer and more open atmosphere. It was apparent that we had to deal with the situation at more than just bar level if we were to be effective. Therefore, in addition to setting down policy guidelines for the bar owners, we decided also to meet with the Vice Squad and the State Liquor Auth.

From these perspectives we drew up a set of bar guidelines based on observations of charges used by the S.L.A. in the past, unacceptable practices by various bars, common sense rules and, most importantly, legal rulings defining acceptable conduct in the bars. In conjunction with this we arranged meetings with Capt. Kennedy of the Vice Squad and Deputy Commissioner Coffey, head of the local S.L.A. office, to discuss our policy guidelines and confront them on their prejudice toward gays. The following is a brief outline of the policy guidelines drawn up for the bars:

- 1) Bars should not discriminate because of race, sex or age.
- 2) Bars should end their 'no touch' policies and allow such forms of touch as hugging, kissing, holding of hands and SLOW DANCING. This is based on a N.Y. State Court of Appeals decision defining where the line should be drawn in terms of 'touch' in bars: "the line must be drawn at public feeling of private parts. In this regard, we would not distinguish between the activities of homosexuals and that of heterosexu-

als." (from: "Becker v. N.Y.S. Liq Auth - 21 N.Y. 2d 289)

- 3) Bar personal should direct their policing activities away from prohibiting permissible forms of touch and concentrate on preventing such violations of the Alcoholic Beverage Control Law as open sex, serving of minors, and preventing fights and use of drugs.

Other guidelines covered utilization of local precinct police to help quell disturbances that get out of hand and adhering to Buffalo Fire Dept. Codes. Our initial step was to present the guidelines to the bar owners and all but one expressed open willingness to cooperate, pending the outcome of our meetings with the Vice Squad and the S.L.A.

We then met with Mr. Coffey of the S.L.A. and Capt. Kennedy of the Vice Squad and found the two meetings to be highly productive in that we made both men well aware of our position regarding what we feel has been overt prejudice on their part and in terms of securing support for our guidelines. Both men were familiar with the court decision we referred to and both said that that decision guided their policy actions. Both Mr. Coffey and Capt. Kennedy expressed good opinions about the bar guidelines and both specifically stated that if the bars followed the guidelines they would not have any problems with the Vice Squad or the S.L.A.

Mr. Coffey denied any prejudice toward gays by the S.L.A. When we disputed his denials by citing specific instances that have occurred recently, he dealt with it by saying he had no knowledge of the incidents. Mr. Coffey did state full knowledge of a Court of Appeals ruling that declared that the mere gathering of homosexuals does not constitute disorderly conduct. Capt. Kennedy also emphasized that the fact that a bar caters to gay clientele does not influence his men in any way. He stated that the 2 violations that his department vigorously pursues are open sex acts and the serving of minors.

Our next step is to have a second meeting with each of the bar owners and discuss with them, in detail, the results of our meetings with Mr. Coffey and Capt. Kennedy. Basically, both of these men feel that any rigid policies on the part of the bar owners are simply self-imposed by the owners and that any blame being leveled against the S.L.A. and the Vice Squad is unjust and simply a result of misunderstandings. On the other hand, several of the bar owners claim that any departure from the rigid policies subjects them to undue scrutiny and harassment from the Vice Squad.

At this time we can only assess the situation with a fair degree of optimism based on our talks with Mr. Coffey and Capt. Kennedy. There has been a perceptible change in the policies of at least one recently opened bar and we should hope that the rest follow suit shortly. We definitely can state that there is no need for a 'no touch-no slow dancing' policy on the part of any bar owner and that if the bars accept our guidelines

New hours at the Gay Community Services Center--Daily 3PM to 10PM, weekends same as before. If in need call any of 14 counselors during open hours or use our answering service. Recent VD clinic and program held at the Center was a great success.

People are aware of Mattachine, help us continue building positive attitudes--join and help your gay sisters and brothers.

Dear Sisters:

We are a group of lesbian feminists creating a record company called Olivia Records. There are hundreds of women across the country who are creating women's music, music that reflects our experiences, thoughts, and emotions, and is another part of a growing women's culture. We feel that these women should have access to the recording industry and so be able to be heard in all our communities. Olivia Records is being created just for this purpose, a national women's recording company. We are interested in high quality music that is not oppressive to women; music that can be, but does not have to be, overtly political; music that comes from and speaks to all facets of our lives.

Olivia Records will become as independent as possible from the male-supremacist economic system. We will employ only women and will provide those jobs for each other at living wages. We recognize the importance for working out class, race, and age differences among all employees, and it is important that Olivia be a non-oppressive institution in which people can grow and create. It will be operated on a collective basis, in which musicians will control their music, and other workers will control their working conditions.

We will set up our own distribution system and our records will be available to large numbers of women throughout the U.S. and Canada. Any profit made on the sale of the records will go back into the company. No one will get rich at Olivia, but everyone will earn a decent wage, working at something we are creating for ourselves and future feminists.

Olivia Records needs engineers, producers, promotionists, financial managers, distributors, musicians, lawyers, accountants, etc. We need your help. If you are a musician, send us a tape (cassette, reel-to-reel) of your work. Or just send us a letter and tell what you do or where your interest might lie.

We have just finished producing our first record, a 45 rpm of Meg Christian and Cris Williamson to be used for fund-raising, which will be available soon. We start producing our first LP in the next few months, so get in touch with us as soon as you read this. We look forward to hearing from you.

Recently, an article entitled "Women's Lib Chain Reaction Worries 'Hotline' Doctor," appeared in the Buffalo Courier Express. The article, of which pertinent quotes are reprinted, deals with the supposed danger to our society inherent in "female dominance." The doctor, as a 'good' Christian and 'Hotline' doctor feels that women should be in no way ashamed of their "traditional roles in our society. The doctor finds considerable evidence for this opinion in the Bible which "contains answers to all human needs."

The doctor doesn't end at this point, however, and takes his second illogical step and explains his concern with another possibility that emerges with female dominance, "Such a home can create an atmosphere leading to homosexuality in sons of such couples. People like to identify with their fathers; this is true of boys and girls. Mother's always there, but father's a treat so his coming home is a special event," Dr. Steiner explained.

Dr. Steiner went on to say that although he neither condones nor condemns homosexuality, he does rate "homosexuals as being among the world's unhappiest people" and refers to a survey conducted by the Mattachine Society in which 300 homosexuals were asked, "Would you want your son to be a homosexual?" Dr. Steiner continued by saying that "most homosexuals tend to wallow in self-pity. But all of them generally blame their condition on home problems during childhood and adolescence, and on their parents."

The rest of the article brought in what I will call the pseudo-Christian considerations on the implications of homosexuality to one's soul. We can breathe a sigh of relief according to Dr. Steiner because of a catch-all phrase in the New Testament that asserts that "Whosoever (I guess he means that this includes us-) believeth in Him should not perish but have everlasting life."

The main thrust of this article was responded to by a letter-to-the-editor by Bobby Bailey, a Mattachine member-at-large. This was printed by the Courier Express and appears below.

HOMOSEXUAL DISPUTES CONTENTIONS BY DOCTOR

Editor: I am writing in regard to your recent article entitled, "Women's Lib Chain Reaction Worries 'Hotline' Doctor," the reference being to Dr. Oliver J. Steiner. I'd like to state that he could not have gotten his information concerning the question: Would you like your son to be a homosexual? from the Mattachine Society of the Niagara Frontier. This chapter of the Mattachine Society conducted no such survey.

IMPORTANT NOTICE

The Mattachine Society monthly meeting dates have been reorganized as follows:

- I. 1) A structured business meeting is held once a month, with full committee reports and a prepared agenda; the agenda published in the FIFTH FREEDOM, in advance, whenever possible.
 - 2) A 'program meeting' is held once a month in lieu of a second business meeting-which consists of an informative and interesting program, widely advertised beforehand.
 - a) this does not preclude the possibility of calling a special, abbreviated meeting on Program Meeting nights to deal with agenda items of an emergency nature.
- II. 1) The Business Meeting is held on the 1st Sunday of each calendar month, and the Program Meeting is held on the 3rd Sunday of each calendar month.
 - a) this discontinues the pattern of meetings every two weeks
 - b) the schedule avoids any real conflict with all major holiday weekends except Labor Day, but the meetings will be scheduled on the 2nd & 4th Sundays in September, as that month has 5 Sundays.
- 2) The new schedule took effect Sunday, March 3rd.

RATIONALE: Based on past experience, every-other-week meetings have not generated the amount of interest necessary to keep attendance and participation at satisfactory levels. The accustomed pattern of scheduled meetings has not adequately allowed for interesting and informative programs, nor vigorous and productive business meetings. By seeking to reorganize the pattern of meeting dates, it is hoped that we can engender more interest in the workings of our organization and develop a schedule which would seem to be more compatible with the workload of those members which hold positions of responsibility within the organization.

- III. 1) Board Meetings continue to be held twice a month on the Tuesday preceding each Sunday meeting date.

Mr. Perry's book would help a great many of us not only with what he has to say, but it would give all of us the courage we need in this world. Thank you for listening to me.

The article that Gary is referring to was a critique by Arthur Bell of two movies that deal with homosexuality, BUSTING, directed by Peter Hyam and starring Elliott Gould and Robert Blake and THE LAUGHING POLICEMAN, directed by Stuart Rosenberg and starring Walter Matthau and Bruce Dern. BUSTING said Bell, "creates a feeling of revulsion among gay liberationists, but instead of submitting silently (as before) we now yell 'slander' for BUSTING has as much to do with our contemporary lives as, say 'Little Miss Marker, Bride of Frankenstein, or Call of the Wild.'"

The movie BUSTING contains all the stereotypic images of homosexuality that we are used to encountering—"cartoon figures with dolled up faces, fluttering eyelashes and limp wrists." The film is replete with derogatory anti-gay language.

The second film commented upon by Bell—THE LAUGHING POLICEMAN depicts the actions of a gay murderer. Bell implies, however, that he doesn't object to this film "one bit" because the killer just happens to be homosexual and does not

kill because of his homosexuality. This article is in the G.C.S.C. Library and I recommend that everyone read it in its entirety. Gary has also brought up another good point about book reviews for the magazine. I agree and if any of our friends or readers read a piece of gay literature I would appreciate it if you'd send a review to the FIFTH FREEDOM. Gary mentions some particular books that he feels should be recommended to our readers. I would recommend MAURICE as good reading but I caution you against books by Troy Perry. Jack Nichols and Siege Clark authors of "I HAVE MORE FUN WITH YOU THAN WITH ANYBODY," -an excellent book say "If religion is a crutch, then Troy Perry is a brand new wheelchair." Their opinion (and many others') is that Mr. Perry sees God as loving him in spite of his gayness. Books that I can recommend are THE GAY MISTIQUE by Peter Fisher and SOCIETY AND THE HEALTHY HOMOSEXUAL by Dr. George Weinberg.
