ALL THAT TRACT OR PARCEL OF LAND situate in the City of Buffalo, County of Erie and State of New York, being part of Outer Lot No. 106 of the Holland Land Company Survey bounded and described as follows:

BEGINNING at the intersection of the west line of Hickory Street and the north line of Clinton Street; thence westerly along said north line of Clinton Street 51.00 feet; thence northerly and parallel with Hickory Street 87.00 feet; thence easterly and parallel with Clinton Street, 51.00 feet to said west line of Hickory Street; thence southerly on the said west line of Hickory Street 87.00 feet to the place of beginning, containing 4,437.00 square feet.
