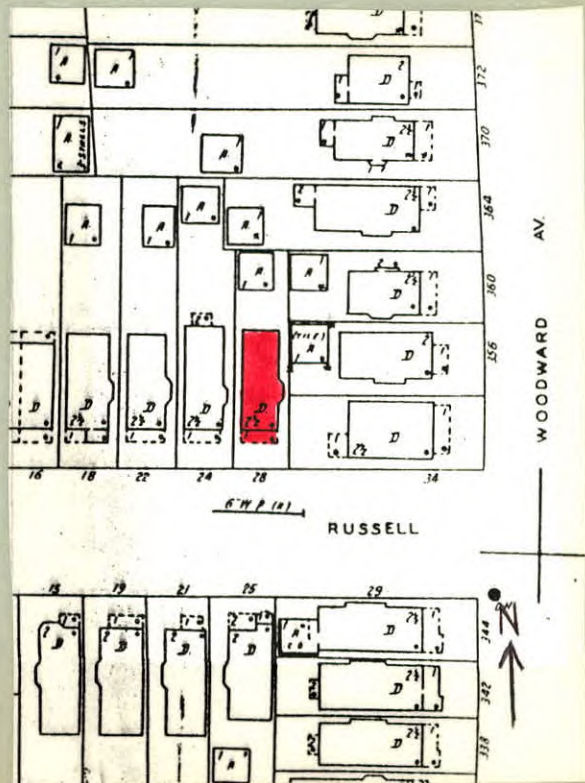

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located one block from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
 Two and a half story frame residence. Front facing gable roof. Bargeboard with flared ends. Full-width flat roof porch with eave overhang. Paired Doric columns. Glass paneled door flanked on one side by rectangular leaded window. First floor 20-light picture window. Second floor semi-hexagonal bay with double hung 1/1 windows. Glass paneled porch door. Projecting pedimented gable. Three-part

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical frame double residence. Russell Avenue extends from Parkside Avenue to Greenfield Street. It was laid out in a map of 1886, paralleling the northern border of the lands of Washington Russell, after whom the street was named. However it was early 1889 before Russell Avenue was deeded to the city. While this particular street does not appear in Olmsted's early 1870's maps of "The Parkside," Olmsted felt cross streets would allow easy access to major thoroughfares and to the park, and he did include similar cross streets such as Jewett Avenue in his early plans.
