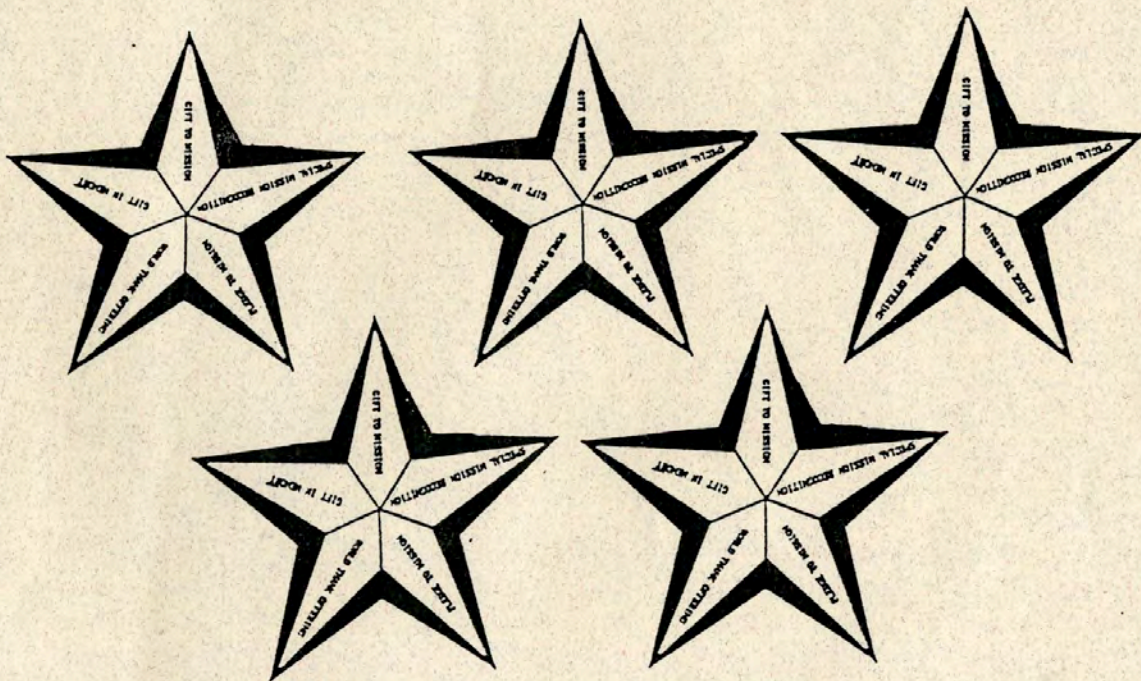

c. counseling costs (limit of \$30,000.00 per year).  
d. counseling cost.

c. essential property (limit of \$100.00) - children  
d. transportation to safe house - children

**NIAGARA COUNTY SHERIFF'S DEPARTMENT  
VICTIM ASSISTANCE UNIT**

There are many services available through the Victim Assistance Unit for victims and their families. The specific services for each are as follows:

**HOMICIDE**

Surviving family members **may** be eligible for reimbursement for:

- a. medical expenses prior to the death.
- b. burial costs up to \$6,000.00.
- c. loss of support (limit of \$600.00 per week or \$30,000.00 per year.
- d. counseling cost.

**SEXUAL ASSAULT**

Victim **may** be eligible for reimbursement for:

- a. medical expenses.
- b. counseling costs - spouse also included.
- c. essential property (limit of \$500.00).

**DOMESTIC VIOLENCE**

Victims **are** eligible for:

- a. transportation to safe house.

Victims **may** be eligible for reimbursement for:

- a. medical expenses - children included.
- b. counseling costs - children included.

**PHYSICAL ASSAULT**

Victims **may** be eligible for reimbursement for:

- a. medical expenses.
- b. counseling expenses.
- c. loss of employment earnings (limit of \$600.00 per week).

**ROBBERY**

Victims **may** be eligible for reimbursement for:

- a. medical expenses.
- b. counseling costs.
- c. cash stolen (limit \$100.00)
- d. loss of essential property.
- e. loss of employment earnings.



**HARASSMENT**

Victims if injured may be eligible for reimbursement for:

- a. medical expenses.
- b. counseling costs.

**CHILD ABUSE  
SEXUAL/PHYSICAL**

Victims and families may be eligible for reimbursement for:

- a. medical expenses.
- b. counseling expenses.

**CRIMINAL MISCHIEF**

Victims must be under 18 or over 60 or disabled to qualify for reimbursement for:

- a. loss of essential property.

**GRAND/PETIT  
LARCENY**

Victims must be under 18 or over 60 or disabled for reimbursement for:

- a. loss of essential property.

**BURGLARY**

Victims must be over 60 or disabled and may be eligible for reimbursement for:

- a. counseling expenses.
- b. loss of essential property (limit of \$500.00).

**DWI FATAL**

Families may be eligible for reimbursement for:

- a. medical expenses prior to the death.
- b. counseling costs for immediate family members.
- c. funeral expenses (limit of \$6,000.00).
- d. loss of support (limit of \$600.00 per week/\$30,000.00 per year).

**DWI INJURY**

Victim may be eligible for reimbursement for:

- a. medical expenses.
- b. counseling expenses.
- c. loss of employment earnings (limit \$600.00 per weeks/\$30,000.00 per year).
