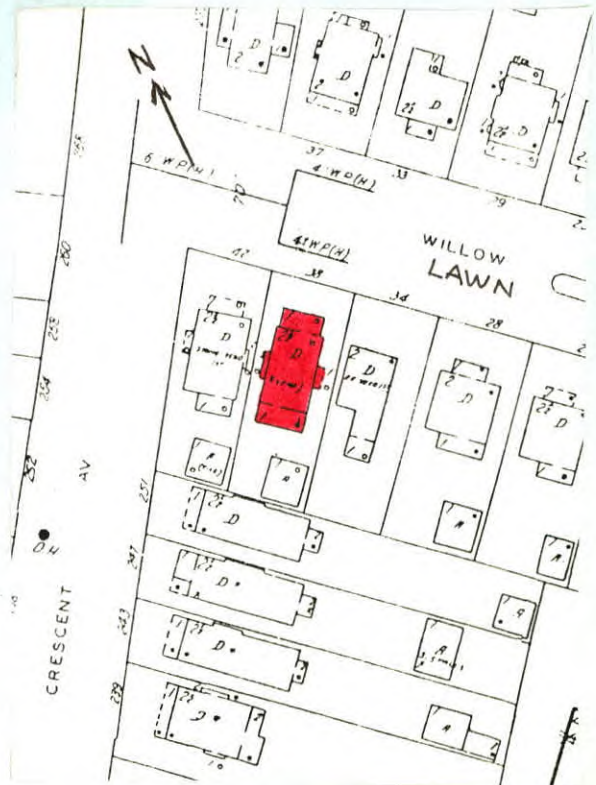

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located four blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story brick American Four Square form. Hip roof with exposed rafter tails under flared roof eaves. Full-width enclosed hip roof porch. Extending roof eaves. Brick end pier supports with column elaboration. Arched span between supports. Horizontal band of 8 double-hung 1/1 windows. End paired windows have 4-light transom. Center windows have 8-light transom. Stone sill. A window box with irregularly curved ends supported by extending wall brackets is centered under

19. DATE OF INITIAL CONSTRUCTION: 1917 band of windows. Second floor

ARCHITECT: center bay has small rectangular leaded glass window. End semi-hexagonal oriels with bracket supports.

BUILDER: Double-hung 6/1 center with 4/1 sides. Hip roof dormer has exposed rafter tails under flared extending eaves.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Three double-hung 6/1 windows.

An American Four Square with Craftsman styling. East side has gabled entrance hood with curved bracket supports. Stick styling in gable. Glass paneled door with sidelights.

Willow Lawn, a one-block street between Crescent Avenue and Main Street just south of Jewett Parkway, is located on the lands of Elam R. Jewett and was named after the Jewett homestead. The last street to be created in the eastern portion of the Parkside subdivision, Willow Lawn was deeded to the city by Jewett's widow in 1905. It is the only Parkside street with a grassy median. While this specific street does not appear on Olmsted's 1870's maps of "The Parkside," it follows Olmsted's subdivision rule of providing easy access to a major thoroughfare leading toward downtown.
