I am in receipt of the form you returned to National Headquarters regarding the Niagara Falls chartering date. There is a conflict in your date and the date we have on record.

Our records show that the Buffalo Chapter was chartered in May of 1950 (no exact day) and that the Niagara Falls Chapter (which, as I understand it) was a division from the Buffalo Chapter which was chartered in 1952, so the June 24, 1950 date for the chartering of the Niagara Falls Chapter is not clear.

I realize that this request may be bothersome to you, but I do hope you understand our desire to clear up our history while those who witnessed it are still with us.

I am sending a copy of this letter to Link Hardiman with the hope that old records, newspaper clippings or some such will aid us in our search for the exact chartering dates of the Buffalo and Niagara Falls Chapters. By the way, do you know who the chartering officer was? Perhaps she can help us if she is still living.
