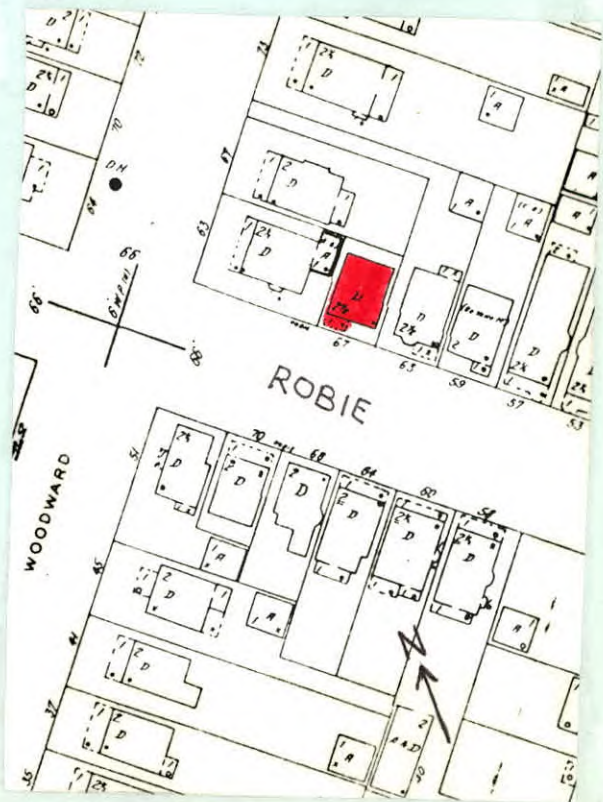

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

(Indicate if building or structure is in an historic district)

Building is situated on a small corner lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story with Queen Anne style influence. Cross gable roof. Partial-width gabled porch. End Doric column supports with center square Doric support. Entablature with small brackets under cornice. Bargeboard with flared end. Aluminum door flanked by 3/4 length leaded sidelights. Double-hung 1/1 window flanks entrance.

SIGNIFICANCE Shed roof boxed first floor bay. Two 6/6 light windows

19. DATE OF INITIAL CONSTRUCTION: c. 1894 with flanking 4/4 light windows. Clapboard first floor. Slight second floor overhang with brackets. Second floor right bay has three-part window. Double-hung 6/1 window. Left bay has paired double-hung 6/1 windows. Shingled second floor. Cross-gable dormer

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: with three-part window, 6/1 lights each.
A simple Queen Anne style residence. Robie Street extends from Parkside Avenue to Main Street. Located in the center of the first section of the Parkside subdivision to be developed, on lands owned by Jacob Davis, Robie Street was deeded to the city in December 1887. Olmsted's early 1870's maps of "The Parkside" show a street angling from Humboldt to Parkside Avenue; however when Robie Street was laid out, it paralleled Humboldt Avenue. The street nevertheless still followed Olmsted's plan to have short cross streets in the subdivision, giving residents easy access to main thoroughfares and the park.
