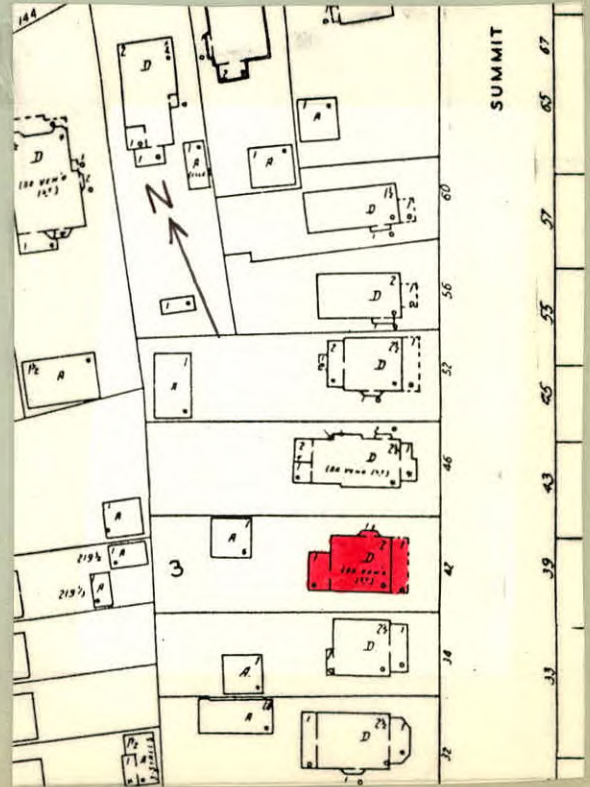

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story with influence from Shingle style. Steep pitched side gable roof. Full-width porch contained under roof's gable. Doric columns support entablature. Brick first floor. Segmental arched entrance has glass paneled door. Segmental arched first floor window, three part, 1/1 windows.

SIGNIFICANCE Over-size pedimented gable dormer. Three-part single light window.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A good example of a Shingle styled residence. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
