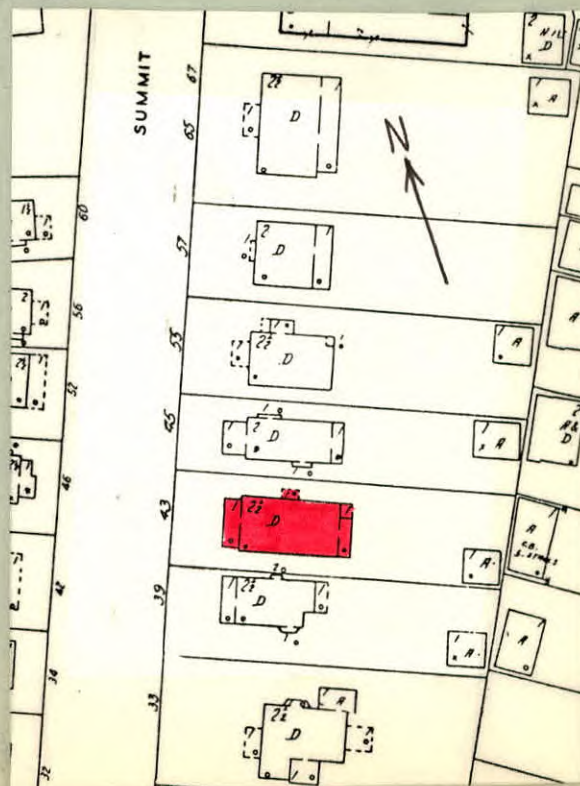

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story with Swiss chalet details applied. Front-facing gable roof with extending side eaves and elaborate cut-out bargeboard. Full-width flat roof wing has three window bays each with three single light windows. Bays flanked by pilasters and bracket shapes at capital. Second floor has two gabled boxed bays. Cut-out pattern bargeboard, 6/1 windows with paneled strips flanking.

Second floor band course. Gable has 6/6 window with surround decorated with strapwork.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: This residence, influenced in form by the Prairie School style, has elaborately cut-out bargeboards reminiscent of Swiss chalets. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
