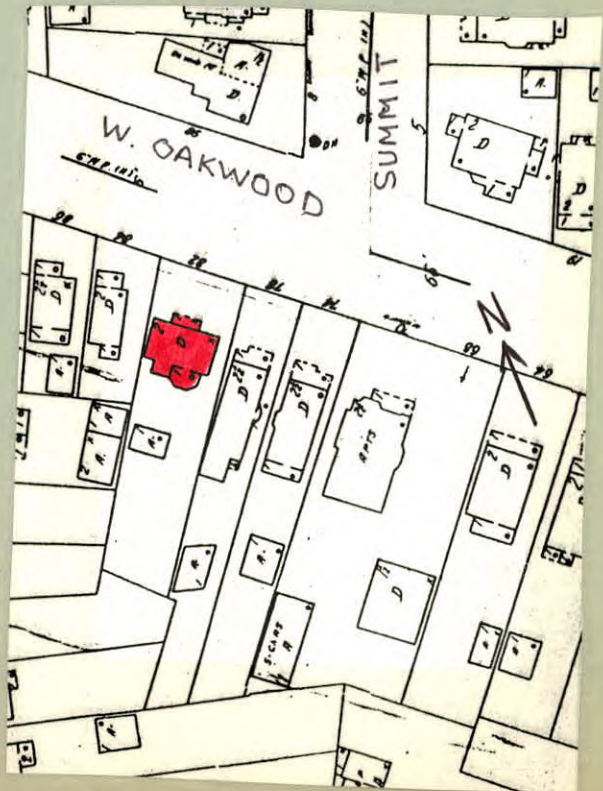

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two story Colonial Revival style. Side gable roof with modillions under roof eave. Cornice end returns. Symmetrical facade. Pedimented gable entrance porch, enclosed. End Doric fluted engaged columns. 4-light wood paneled door. Single-light rectangular casement windows. Frieze decorated with bull's eye motif. Dentils under cornice. First floor end bays have double-hung 1/1 windows. Entablature

19. DATE OF INITIAL CONSTRUCTION: 1905

ARCHITECT: Green & Wicks

BUILDER: End bays have 8/1 double-hung windows. End Doric pilaster strips.

window surround. Second floor center bay has rectangular casement window, single light.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A more traditionally scaled Colonial Revival style. West Oakwood Place extends from Main Street to Parkside Avenue. At the northern border of the first section of the subdivision to be developed, the eastern portion of West Oakwood was deeded to the city by Jacob Davis in 1887 and the remainder by Caroline Jewett in 1888. West Oakwood closely resembles a street found in Olmsted's early 1870's maps of "The Parkside." While it does not connect with Jewett Avenue at the park entrance as Olmsted originally planned, it remains curvilinear and as a cross street provides easy access to the main thoroughfares and the park.
