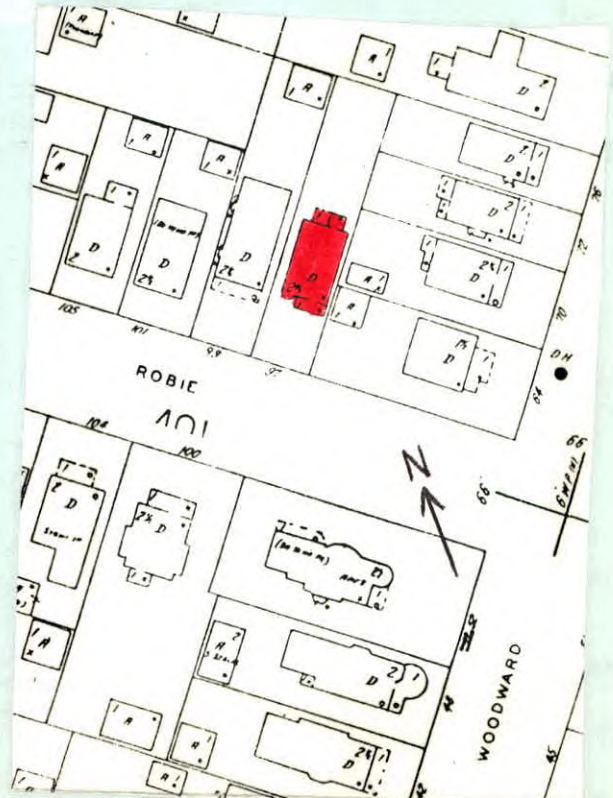

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located one block from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story Queen Anne style. Hip roof. Partial width hip roof enclosed porch. End piers with paneled capitals. Glass paneled door flanked by 1/2 leaded sidelights. Leaded stained glass transom. Three single-light windows. Leaded stained glass transom. Second floor center bay has tri-partite window; double hung 1/1 lights. Left corner bay has two story

SIGNIFICANCE

19. DATE OF INITIAL CONSTRUCTION: 1898
ARCHITECT: floor double-hung 1/1 windows. Plain window
BUILDER: surrounds. Hip roof dormer has two single-light casement windows.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A simplified form of the Queen Anne style. Robie Street extends from Parkside Avenue to Main Street. Located in the center of the first section of the Parkside subdivision to be developed, on lands owned by Jacob Davis, Robie Street was deeded to the city in December 1887. Olmsted's early 1870's maps of "The Parkside" show a street angling from Humboldt to Parkside Avenue; however when Robie Street was laid out, it paralleled Humboldt Avenue. The street nevertheless still followed Olmsted's plan to have short cross streets in the subdivision, giving residents easy access to main thoroughfares and the park.
