

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

(Indicate if building or structure is in an historic district) Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known): Two and a half story American Four Square. Hip roof with extending eaves. Partial-width hip roof enclosed porch. Extending eaves. End piers flank horizontal band of 4 windows, 12 lights each. Left side has glass and wood door with half length two-light sidelights. Four light transom. 8-light window flanks on one side. Left bay first floor has paired single-hung single-light windows. <u>SIGNIFICANCE</u> 19. DATE OF INITIAL CONSTRUCTION: C. 1909 With band course at second

ARCHITECT: floor window sill level. Boxed second floor bay has three single-hung windows; 16 lights in top light. BUILDER: Sides of bay have single 16/1 light window. Left bay has paired 6/1 double-hung windows. Hip roof

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: dormer has two 12-light Typical American Four Square. rectangular windows. West Oakwood Place extends from Main Street to Parkside Avenue. At the northern border of the first section of the subdivision to be developed, the eastern portion of West Oakwood was deeded to the city by Jacob Davis in 1887 and the remainder by Caroline Jewett in 1888. West Oakwood closely resembles a street found in Olmsted's early 1870's maps of "The Parkside." While it does not connect with Jewett Avenue at the park entrance as Olmsted originally planned, it remains curvilinear and as a cross street provides easy access to the main thoroughfares and the park.
