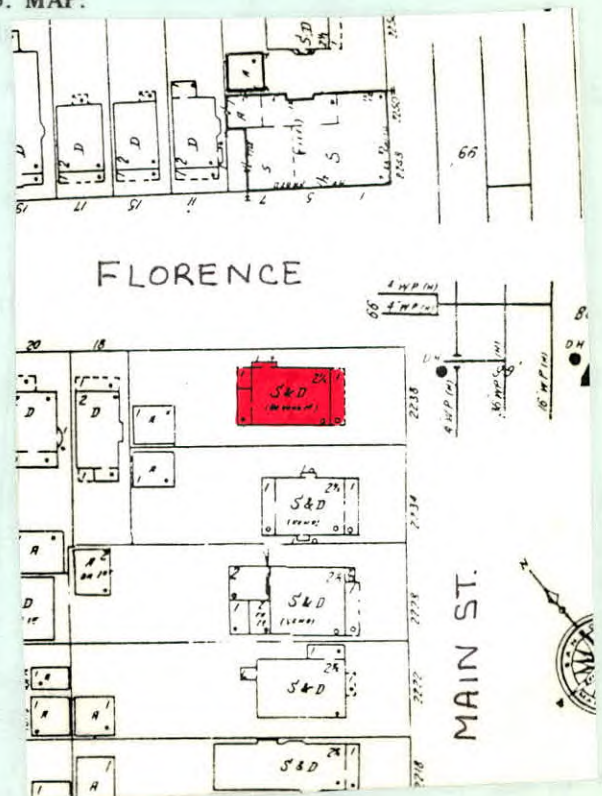

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story American Four Square. Hip roof with exposed rafter tails under extending eaves. Full-width hip roof wing has three-light wood door. Sidelights. Tripartite windows; center single light with 4-light sidelights. Brick first floor. Second floor has a set of paired 6/1 windows placed under roof eave.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Typical American Four Square with the front wing altered at later date. Originally the Buffalo and Williamsville Macadam Road, Main Street was a pre-existing street at the time Olmsted designated it as the eastern border for "The Parkside." While the streets within the subdivision were designed specifically to avoid commercial development, this portion of Main Street became a combination of commercial and residential structures. It was also a major thoroughfare into the city, allowing easy access to downtown from this suburban neighborhood.
