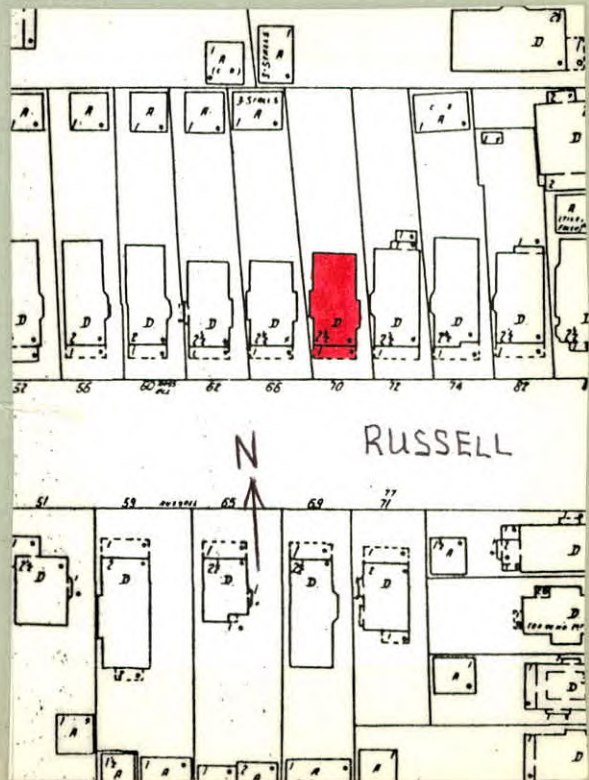

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story frame with front facing gable roof. Full-width hip roof porch with pediment at right end. Tympanum decorated with vine and urn motif. Square supports on pedestals and stick balustrade. Projecting boxed entrance has three-light wood door flanked on one side by small double hung 1/1 window. First floor left bay has single hung single-light window with single-light top light.

SIGNIFICANCE

19. DATE OF INITIAL CONSTRUCTION: 1899 Second floor semi-hexagonal bay. Double hung 1/1 windows. Right bay has double-hung 1/1 windows. Plain window surround. Pedimented gable has large curved brackets at ends. Three-part window; double hung 1/1 light.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A simple frame gabled residence found throughout Buffalo. Russell Avenue extends from Parkside Avenue to Greenfield Street. It was laid out in a map of 1886, paralleling the northern border of the lands of Washington Russell, after whom the street was named. However it was early 1889 before Russell Avenue was deeded to the city. While this particular street does not appear in Olmsted's early 1870's maps of "The Parkside," Olmsted felt cross streets would allow easy access to major thoroughfares and to the park, and he did include similar cross streets such as Jewett Avenue in his early plans.
