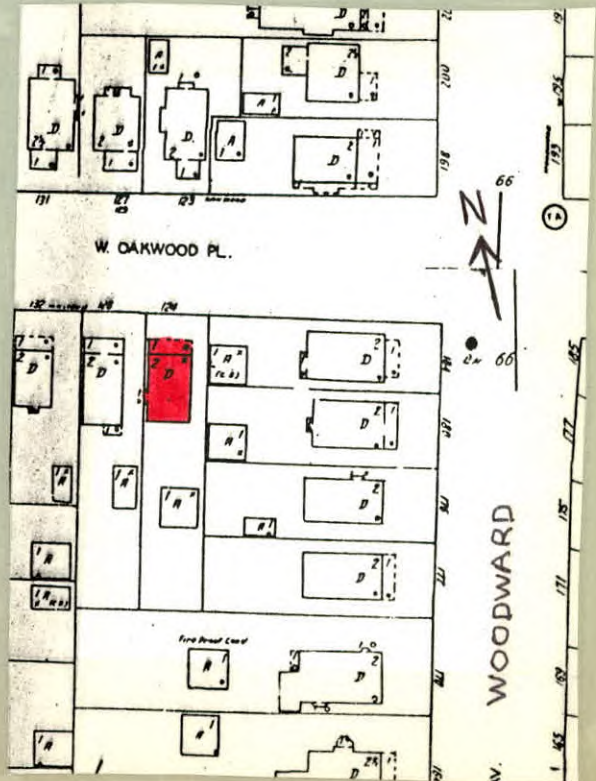

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located one block from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story frame residence. Hip roof with flared extending eave. Full-width flat-roof spans first floor. Boxed entrance bay has 4-light wood paneled door. Left bay has rectangular leaded window. Right bay has tri-part window. Single light with casement side windows. Second floor has two semi-hexagonal bay windows. Double-hung 1/1 windows. Plain window surrounds.

Hip roof dormer has tri-part window. Double-hung with arched tracery in top light.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:

A typical American Four Square form. West Oakwood Place extends from Main Street to Parkside Avenue. At the northern border of the first section of the subdivision to be developed, the eastern portion of West Oakwood was deeded to the city by Jacob Davis in 1887 and the remainder by Caroline Jewett in 1888. West Oakwood closely resembles a street found in Olmsted's early 1870's maps of "The Parkside." While it does not connect with Jewett Avenue at the park entrance as Olmsted originally planned, it remains curvilinear and as a cross street provides easy access to the main thoroughfares and the park.
