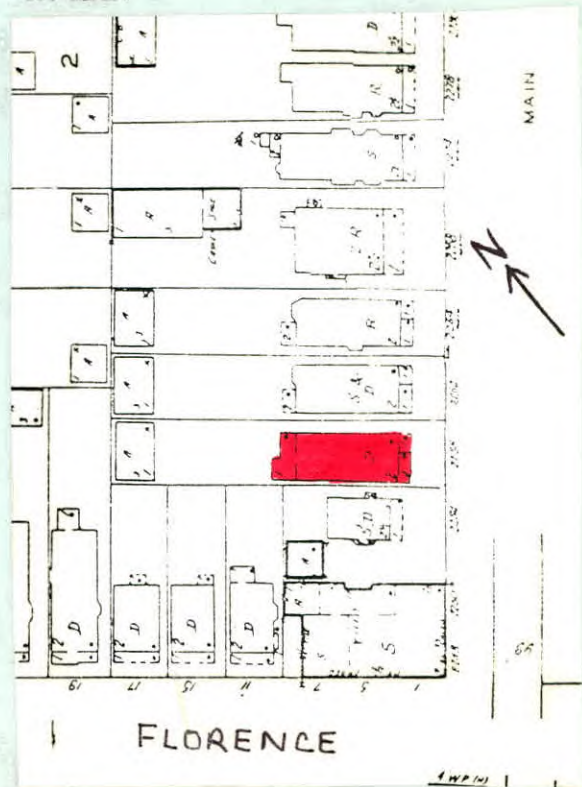

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):  
Two and a half story with Prairie School influence. Hip roof with extending eaves. Full-width flat roof porch, partially enclosed. Rough-cut regular course stone base. Tapered paneled square pilaster strips flank horizontal band double-hung windows. Three vertical light windows in top light. End tapered, paneled corner porch support. Lighted glass door with glass and wood paneled door on

**SIGNIFICANCE**  
19. DATE OF INITIAL CONSTRUCTION: 1920  
ARCHITECT: porch. Clapboard first floor. Second floor semi-hexagonal bay with double-hung windows. Three vertical lights in top light.  
BUILDER: Lighted double sash porch door. Porch rail has vertical cut-outs. Hip

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: roof dormer has three windows, three vertical lights each.  
A typical form of a simplified Prairie School form. Similar to 2262 and 2264 Main Street in building style. Originally the Buffalo and Williamsville Macadam Road, Main Street was a pre-existing street at the time Olmsted designated it as the eastern border for "The Parkside." While the streets within the subdivision were designed specifically to avoid commercial development, this portion of Main Street became a combination of commercial and residential structures. It was also a major thoroughfare into the city, allowing easy access to downtown from this suburban neighborhood.
