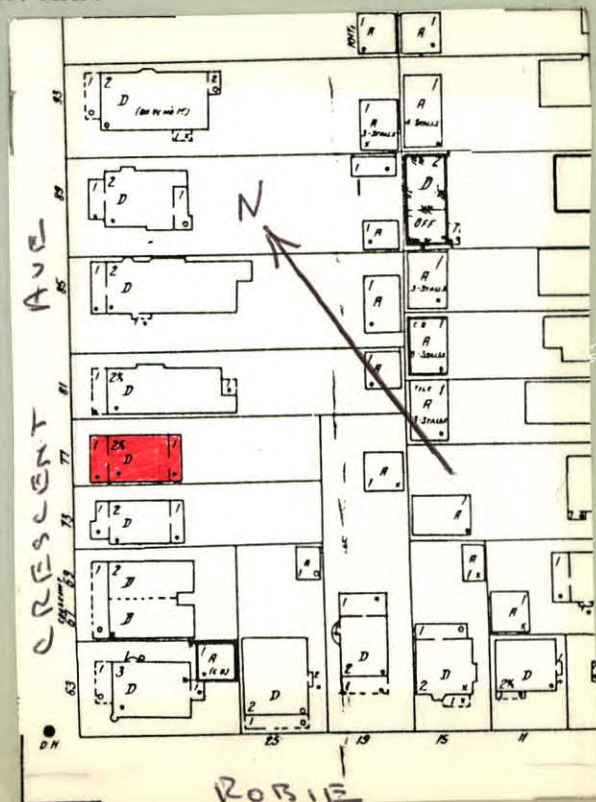

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):  
 Two and a half story with side gable roof. Bargeboard and exposed rafter tails under projecting eaves. Partial-width shed roof extends to full-width hip roof porch, enclosed. Exposed rafter tails under eave. Three light wood panel door with slender transom and sidelights flanked by 6-light window. Pair of 9-light porch windows. Second floor has a set of paired 6/1 windows. Shed roof

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A frame residence with a basic application of Craftsman style details. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
