

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS: (Indicate if building or structure is in an historic district)

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located four blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known): Two and a half story frame residence with front facing gable roof. Full-width hip roof porch with pediment over stairs at right end of porch. Glass and wood paneled door with diamond tracery in glass panel. Door flanked on one side by small rectangular leaded window. First floor single light picture window with diamond-shaped tracery. Second floor has clipped end bays. Double hung 1/1 SIGNIFICANCE windows. Main facade second 19. DATE OF INITIAL CONSTRUCTION: _ C. 1898 floor has two double hung

ARCHITECT: 1/1 windows. Band trim under gable eave. Pedimented gable with paired end brackets. Tri-part gable window; full-size window, 1/1 light, flanked by small 1/1 BUILDER: windows.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A simplified version of a gabled Colonial Revival style residence, a typical housing form found throughout Buffalo. Greenfield Street extends from Amherst Street to Main Street, paralleling the Belt Line Railroad. Although Greenfield Street was deeded to the city in 1889, it was laid out in 1886 by the Parkside Land Company, which had purchased the land between Amherst Street and West Oakwood Place from two major landowners, Elam R. Jewett and Washington Russell. A street very similar in configuration appears in Olmsted's early 1870's maps of "The Parkside." Greenfield follows Olmsted's plan for providing easy access to major streets while being too narrow for extensive commercial development, although some commercial buildings can be found near Main Street. 21.
