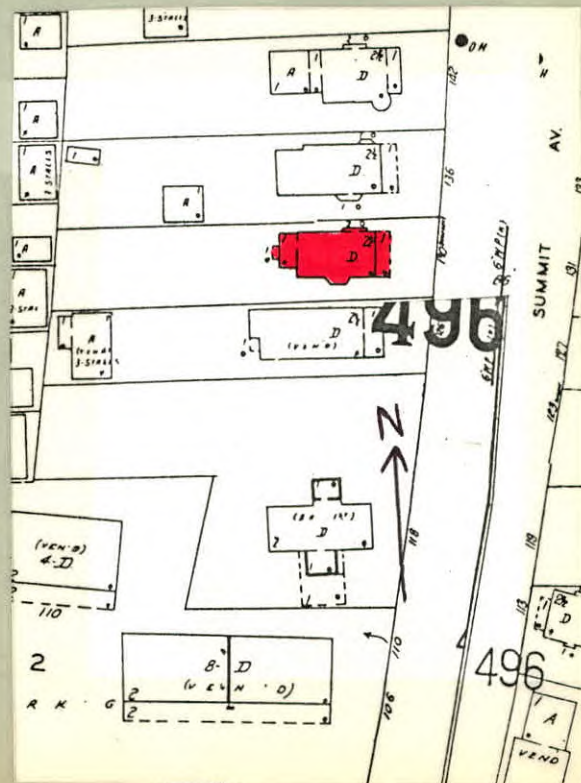

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story frame with front facing gable roof. Front facing flat-roof porch. Paired square supports. Glass paneled door flanked on one side by single light window with transom. Tri-part first floor window, single lights with transoms. Second floor bowed bay. 1/1 windows. Single 1/1 light window on second floor. Pedimented gable has three-part window; 1/1

SIGNIFICANCE

19. DATE OF INITIAL CONSTRUCTION: c. 1894 center enframed by round arch. Small 1/1 windows flank center windows.
ARCHITECT: _____ Shingled round arch spans window.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Frame residence is typical of Colonial Revival style influenced by Queen Anne style. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
