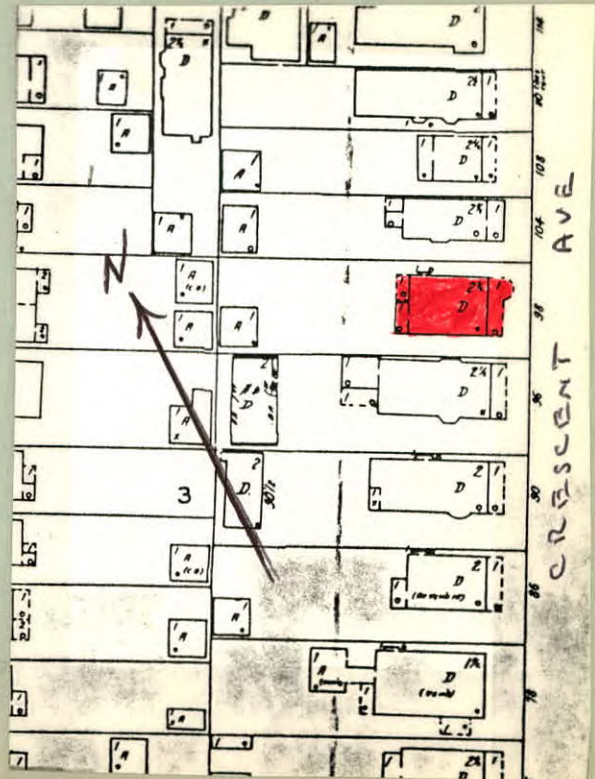

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):  
 Classical Revival with hip roof and fluted pilaster corner boards. Pedimented facade dormer has scroll work tympanum. Large porch has circular extension and is supported on slender fluted columns. Doorway sidelights have leaded glass.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Typical hip-roof Colonial Revival type of the turn of the century in Parkside with an exceptionally fine and unusual porch. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special
