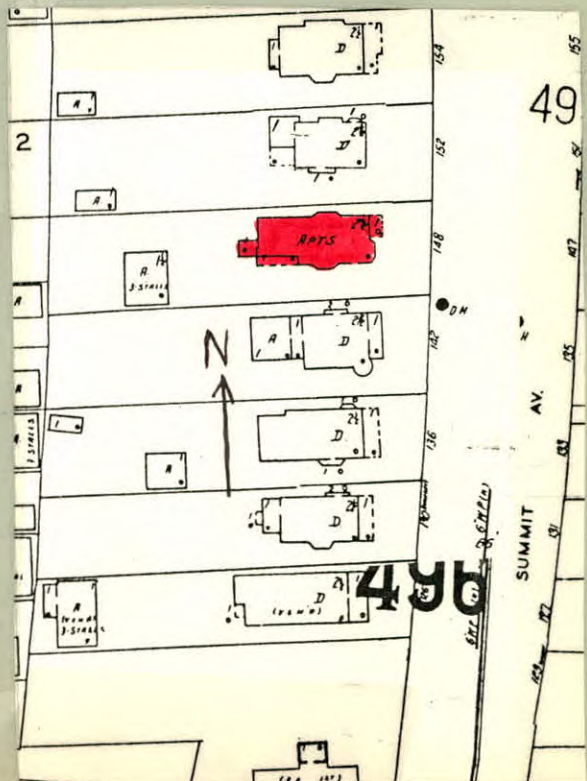

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story with Queen Anne styling. Gable on hip roof. Gabled two and a half story semi-hexagonal bay. First and second floor 1/1 windows. Curved brackets support shingled pedimented gable. Square single light window. Entablature window surround. Bowed fluted window base. Hip roof entrance porch. Glass and wood paneled door flanked by

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: The asymmetrical shape and relatively simple, unornamented surface associates this house to Princess Anne style. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
