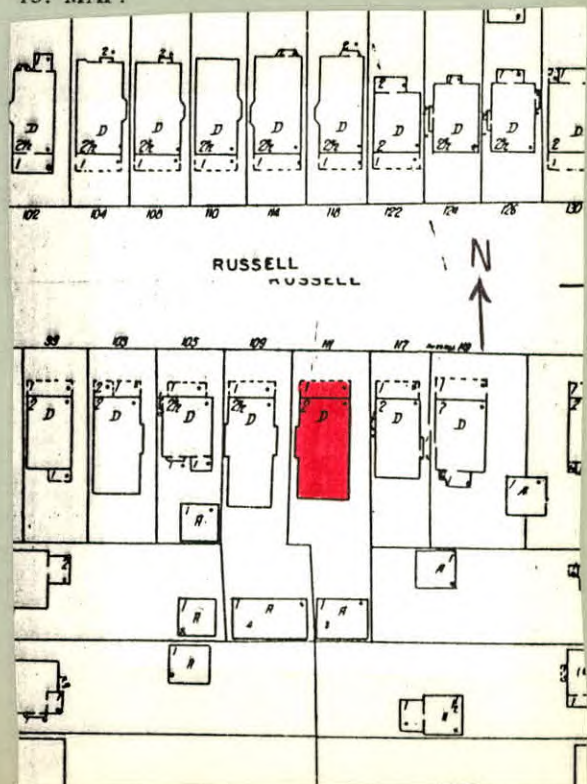

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story American Four Square. Hip roof with exposed rafter tails under extending eave. Full-width flat roof porch with eave overhang. Brick base and pedestals. Tapered square Doric supports. Paneled rail. Glass and wood paneled door. Horizontal and vertical borders in glass panel. Three-part single-hung single light windows, first floor right bay. Clapboard first floor. Second floor left bay

SIGNIFICANCE

19. DATE OF INITIAL CONSTRUCTION: 1916
ARCHITECT: part single hung, single light window. Plain window surrounds. Shingle second floor. Hip roof dormer.
BUILDER: Three rectangular windows. Single light with horizontal and vertical bands.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical American Four Square with Craftsman style details. Russell Avenue extends from Parkside Avenue to Greenfield Street. It was laid out in a map of 1886, paralleling the northern border of the lands of Washington Russell, after whom the street was named. However it was early 1889 before Russell Avenue was deeded to the city. While this particular street does not appear in Olmsted's early 1870's maps of "The Parkside," Olmsted felt cross streets would allow easy access to major thoroughfares and to the park, and he did include similar cross streets such as Jewett Avenue in his early plans.
