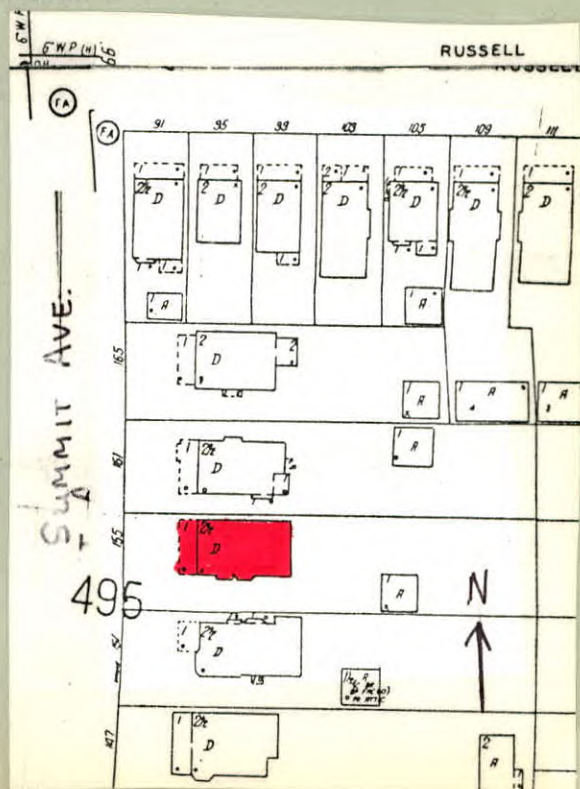

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story Colonial Revival style. Hip roof with brackets and curved end brackets under eave. Full-length flat roof porch with Ionic columns supporting entablature. Stick balustrade. Glass and wood paneled door flanked on one side by 1/1 window. Three part 1/1 first floor window. Second floor bowed shingled bay. Center 1/1 window with single

SIGNIFICANCE light sidelights. Shingled boxed bay on second floor
19. DATE OF INITIAL CONSTRUCTION: 1909
ARCHITECT: has a pair of 1/1 windows. End pilaster strips. Segmental arched pedimented dormer. End Ionic pilasters flank three-part double hung windows with arched tracery in top light.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical hip roof Colonial Revival style residence with full-width porch built prior to 1915. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
