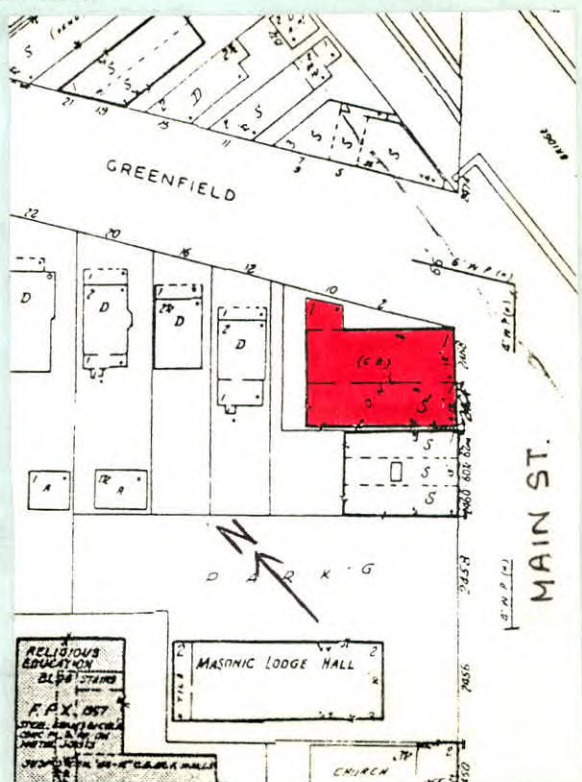

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. It is located four blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
 One story concrete block commercial building with brick facade. Flat roof. Centrally located recessed entrance. Glass door with sidelights. Large single light glass windows extend along facade in ribbon fashion. Windows to north wrap around corner. Metal cap at roof level.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A one-story commercial building that exhibits Modern style details. Originally the Buffalo and Williamsville Macadam Road, Main Street was a pre-existing street at the time Olmsted designated it as the eastern border for "The Parkside." While the streets within the subdivision were designed specifically to avoid commercial development, this portion of Main Street became a combination of commercial and residential structures. It was also a major thoroughfare into the city, allowing easy access to downtown from this suburban neighborhood.
