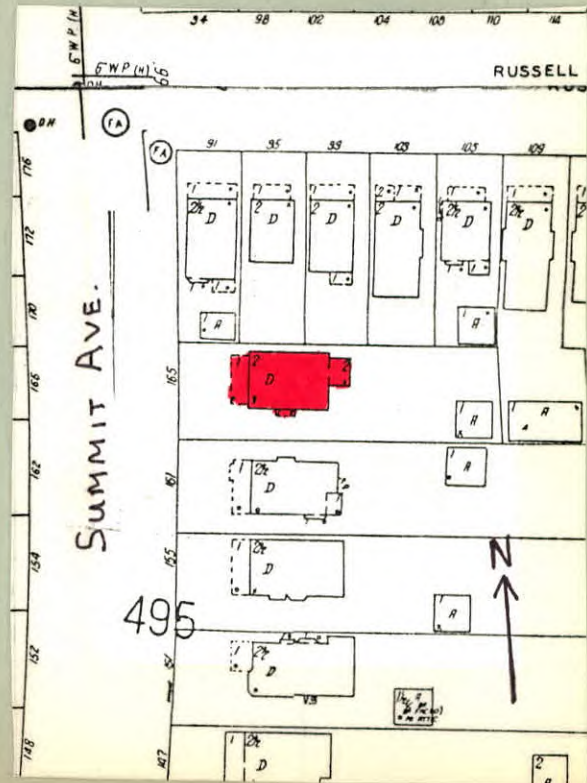

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story frame residence with front facing gable roof. Full-width hip roof porch with Doric columns supporting entablature. Pair of double-sash lighted porch doors. Second floor 8/1 windows. Window shutters. Paneled band spans second floor. Gable has pair 6/1 windows with entablature window surround. Hip roof entrance porch on south side. Doric columns support

SIGNIFICANCE entablature. Wood paneled door with lighted sidelights. Bargeboard with flared ends. Nails head motif decorates.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A residential structure situated on a narrow urban lot. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
