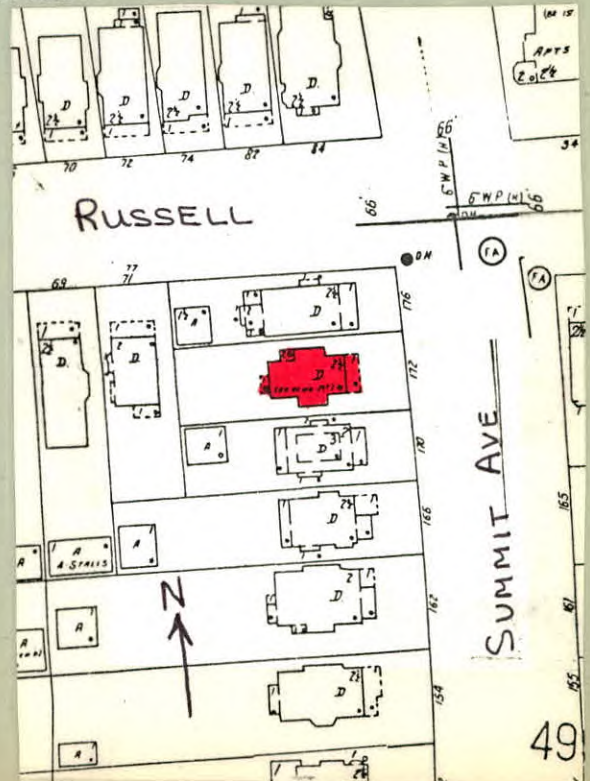

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
Two story Prairie School style. Hip roof with flared projecting eave. Full-width hip roof porch. Extending eaves. Brick pier supports. Double sash, 10 lights, porch doors flanked by 4 light small rectangular windows. Brick first floor. Band course. Stucco second floor. Two 6/1 windows on second floor. North side entrance, 8 light door.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A good example of a vernacular version of Prairie School style residence. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
