

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS: (Indicate if building or structure is in an historic district)

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known): Two and a half story American Four Square form. Hip roof with extending eave. Cruved brackets under eave. Full-width hip roof porch. Wood base with lattice-work panels. Square Doric supports. Entablature with ancone brackets under cornice. Stick balustrade. Glass and wood paneled door flanked on one side by small rectangular window. Diamond shaped tracery. First floor three-part window. Double-hung with Gothic NECHTERANCE DUILD CONSTRUCTION. 1908 arched tracery in top light.

19. DATE OF INITIAL CONSTRUCTION: 1908

ARCHITECT: surround. Second floor has two three-part windows imitating first floor. Band of trim below eave. Hip BUILDER: roof dormer has curved brackets under eave. Two double hung windows with diamond-shaped tracery in

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: top light. A typical American Four Square with Craftsman style details. Russell Avenue extends from Parkside Avenue to Greenfield Street. It was laid out in a map of 1886, paralleling the northern border of the lands of Washington Russell, after whom the street was named. However it was early 1889 before Russell Avenue was deeded to the city. While this particular street does not appear in Olmsted's early 1870's maps of "The Parkside," Olmsted felt.cross streets would allow easy access to major thoroughfares and to the park, and he did include similar cross streets such as Jewett Avenue in his early plans.
