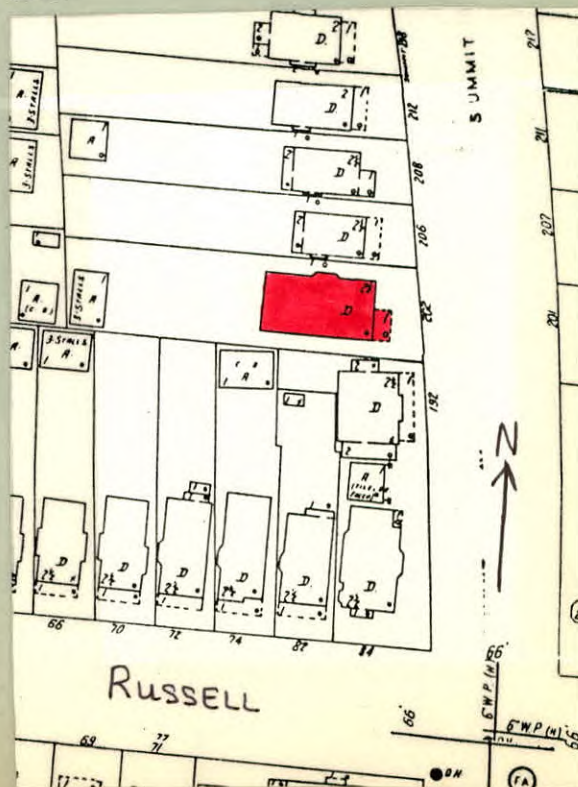

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story Colonial Revival style. Front facing gable roof. Partial-width flat roof porch. Recessed entrance has glass paneled door. 1/1 first floor window. Two story semi-hexagonal bay. 1/1 windows. Second floor paneled apron. Entablature window surround. Second floor has pair of glass paneled porch doors. Entablature window head.

SIGNIFICANCE

19. DATE OF INITIAL CONSTRUCTION: 1901 Paneled end pilaster strips. Pedimented gable has modillions and brackets under projecting gable. Palladian style window.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: This gable frame residence utilizes details, such as pilaster strips and Palladian window, that are characteristic of Colonial Revival style. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
