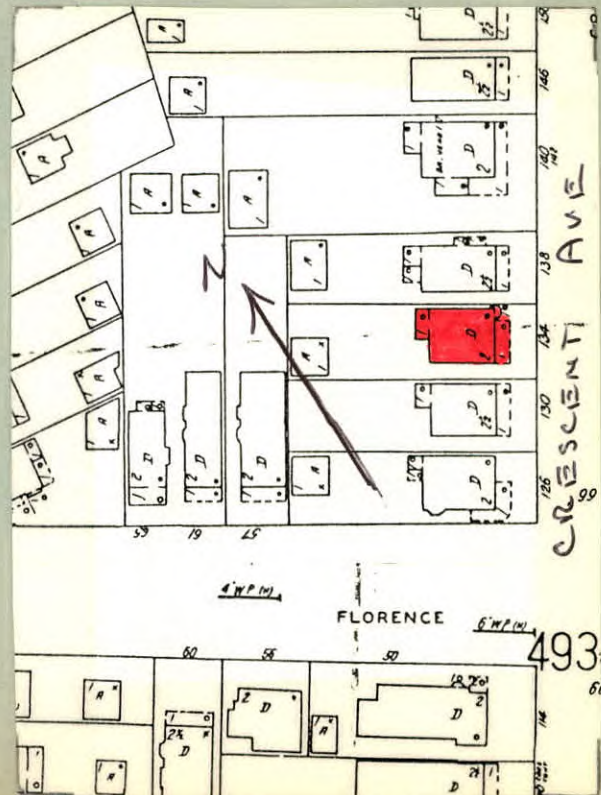

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:
(Indicate if building or structure is in an historic district)

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
Two and a half story with steep pitched hip roof with extending eaves. Exposed rafter tails with curved ends and massive brackets with pendants under eave. Partial-width flat roof porch has square rough cut, regular course stone supports. Spindle balustrade. Wood paneled door. First floor tri-part window, 12/12 lights.

SIGNIFICANCE Semi-circular first floor bay has 18 light casement window. Second floor small square leaded window flanked by 1/1 windows. Hip roof dormer has exposed rafter tails under extending eaves. Dormer has a pair of 1/1 windows. Semi-circular dormer on west side.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A Craftsman style residence with shingle style influences. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
