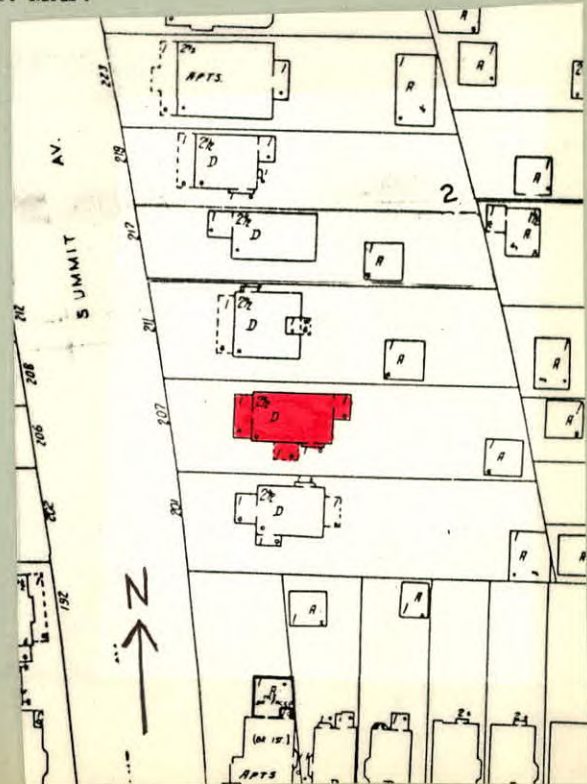

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):  
 Two and a half story American Four Square. Hip roof with extending eaves. Full-width shed roof wing. Tapered pilaster strips flank single light windows with 4 vertical light transom. Tri-part second floor windows, single light with leaded transoms. Hip roof dormer with center roof chimney. Pair 4 light windows. Hip roof entrance porch on side has square supports. Wood

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical American Four Square. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
