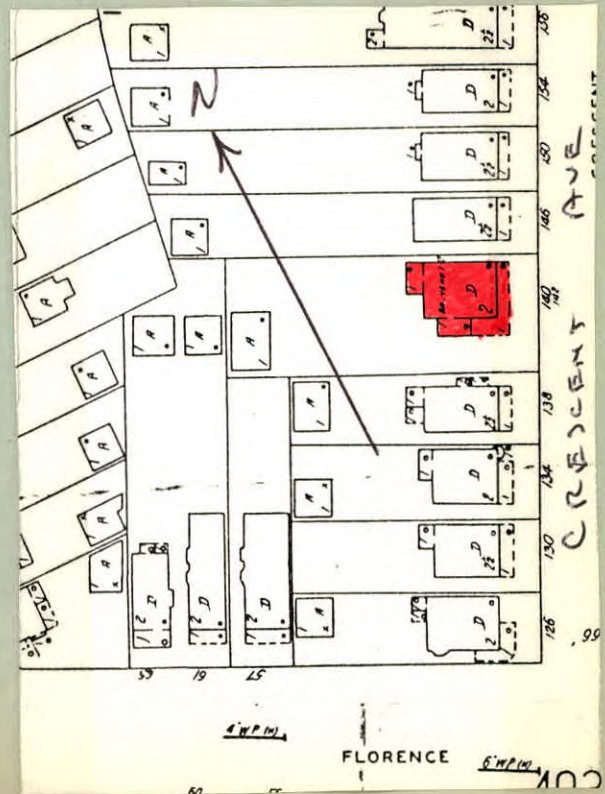

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
 Two and a half story with hip roof. Exposed rafter tails under eave. "L" shaped hip roof porch has gabled projection. Bargeboard with square decorative motifs. Paired square supports with column elaboration. Stick balustrade. First floor brick. Glass paneled door with sidelights. Multi-light double sash doors and multi-light porch door flank rectangular leaded window on first floor.

- SIGNIFICANCE
 19. DATE OF INITIAL CONSTRUCTION: 1910 Shingled second floor has a pair of boxed bays. Paired 9/1 windows in each bay. Hip roof dormer has exposed rafter tails under eave. 4 rectangular windows.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Craftsman style details and Prairie School influence are exhibited on this residential structure. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
