

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
Two and a half story American Four Square with Craftsman styling. Hip roof. Full-width gabled porch. Tapered paneled square supports. Stick rail. Projecting entrance with diamond light wood paneled door. First floor tri-part window, single lights with diamond-shaped tracery in transoms. Clapboard first floor. End bays second floor have paired double hung windows.

- SIGNIFICANCE
19. DATE OF INITIAL CONSTRUCTION: 1914 Diamond-shaped tracery in top light. Lighted transoms. Shingle second floor. Hip roof dormer has two double hung windows with diamond tracery in top light.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical American Four Square with Craftsman styling. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
