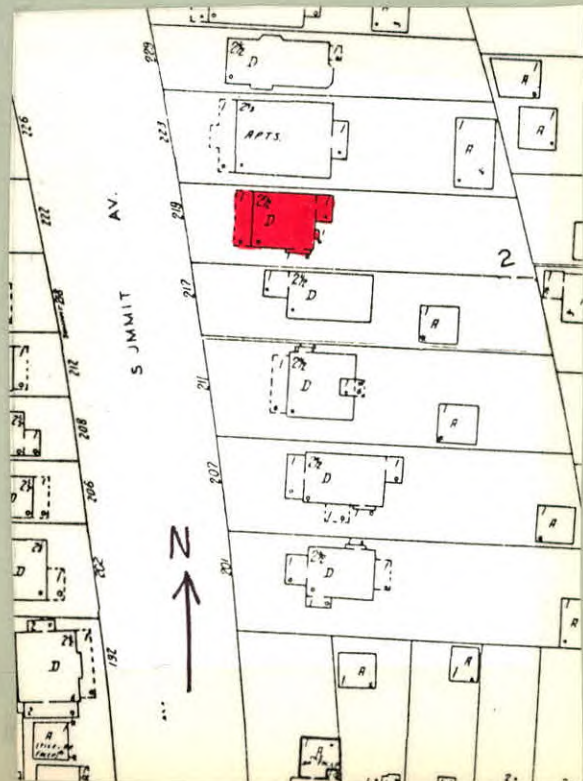

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story American Four Square form. Hip roof. Pedimented gable entrance hood with bargeboard. Glass and wood paneled door flanked on one side by pair 1/1 windows. Four-part first floor window, single lights with leaded transom. Lintel window head. Second floor has a set of paired 6/1 windows. SIGNIFICANCE End fluted Doric pilaster strips. Hip roof dormer has

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical American Four Square with Colonial Revival styling applied. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
